

**AUTHORIZE CONTINUED RETENTION OF THE LAW FIRM  
KANE LADUZINSKY & MENDOZA, LTD.**

**THE GENERAL COUNSEL REPORTS THE FOLLOWING DECISION:**

Continued retention of the law firm Kane Laduzinsky & Mendoza, Ltd.

**DESCRIPTION:** The law firm Kane Laduzinsky & Mendoza was previously retained to represent the Board in Della Coleman, as Special Administrator of the Estate of Derrick Spencer v. Board of Education, Case No. 02 L 7582. While considerable discovery has occurred in this litigation, the General Counsel anticipates the continuation of significant discovery now that the company which owns the hotel where the drowning at issue occurred has been added as a party. Additional authorization for the firm's fees is requested in the amount of \$100,000. As invoices are received, they will be reviewed by the General Counsel and, if satisfactory, processed for payment.


Conflicts - The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board Members during the one year period following expiration or other termination of their terms of office.

Indebtedness - The Board's Indebtedness Policy adopted July 26, 1995, (95-0726-EX3), as amended from time to time, is hereby incorporated into and made a part of the agreement.

Ethics - The Board's Ethics Code adopted September 27, 1995, (95-0927-RU3), as amended from time to time, is hereby incorporated into and made a part of the agreement.

Contingent Liability - The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
