

**ESTABLISH THE NORTH-GRAND (KELVYN PARK SOUTH) HIGH SCHOOL,
ESTABLISH THE ATTENDANCE AREA FOR THE NORTH-GRAND HIGH SCHOOL
AND ADJUST THE ATTENDANCE AREA FOR KELVYN PARK HIGH SCHOOL**

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Establish the North-Grand (Kelvyn Park South) High School located at 4338 W. Wabansia Avenue and establish attendance area boundaries for that school; and adjust the attendance area boundaries for Kelvyn Park High School located at 4343 W. Wrightwood Avenue. Kelvyn Park High School will continue to remain the home school of students currently enrolled at Kelvyn Park, and residing within its current attendance area.

North-Grand High School will enroll students from its attendance area beginning with ninth grade in the 2004-2005 school year, expanding to the subsequent grade in each consecutive year, through school year 2007-2008.

A public hearing was held on the establishment and adjustment of these attendance area boundaries on February 17, 2004 at Kelvyn Park High School.

DESCRIPTION:

North-Grand High School is established to reduce overcrowding at Kelvyn Park High School. Reduction of overcrowding at Kelvyn Park High School is accomplished by assigning a portion of its attendance area to the new North-Grand High School.

The Comprehensive Student Assignment Plan, adopted by the Board of Education on January 22, 1982 (Board Report 82-12), states: "The Board will seek to eliminate overcrowded schools to the greatest extent practicable considering all circumstances."

Adjust Attendance Area Boundaries for Kelvyn Park High School

For grades ninth through twelfth (effective July 1, 2004):

Beginning at the C & NW Railroad and Diversey Avenue
East to Kimball Avenue
South to Cortland Street
West to Pulaski Road
North to Armitage Avenue
West to the C & NW Railroad
North to the starting point.

Additionally, for grades tenth through twelfth for the 2004-2005 school year, for grades eleventh through twelfth for the 2005-2006 school year, and for grade twelfth for the 2006-2007 school year, the following area will continue to be assigned to Kelvyn Park high school.

Beginning at the C & NW Railroad and Armitage Avenue
East to Pulaski Road
South to Cortland Street
East to Kimball Avenue
South to North Avenue
West to the C & NW Railroad
North to the starting point.

Establish Attendance Area Boundary for North-Grand High School:

*Grade ninth: (effective July 1, 2004);
Grades ninth and tenth (effective July 1, 2005);
Grades ninth through eleventh (beginning July 1, 2006);
Grades ninth through twelfth (beginning July 1, 2007):*

Beginning at the C & NW Railroad and Armitage Avenue
East to Pulaski Road
South to Cortland Street
East to Kimball Avenue
South to North Avenue
West to the C & NW Railroad
North to the starting point.


