

Amend Board Report 02-1218-PR32
APPROVE ENTERING INTO AN AGREEMENT WITH
FULFILLING OUR RESPONSIBILITY UNTO MANKIND
FOR THE SATURDAY MORNING REACH OUT AND TEACH PROGRAM
CONSULTING SERVICES

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into an agreement with Fulfilling Our Responsibility Unto Mankind (F.O.R.U.M.) to provide consulting services related to the Saturday Morning Reach Out and Teach (S.M.A.R.T.) Program to Specialized Services - Specialized and Alternative Safe Schools at a cost not to exceed an aggregate amount of ~~\$1,911,576.00~~ \$1,664,952 over a 3-year period (\$576,285.00 for year 1; ~~\$637,191.00~~ \$564,905 year 2; and ~~\$698,100.00~~ \$523,762 for year 3). F.O.R.U.M. was selected pursuant to a duly advertised RFP Solicitation (Specification No. 02-250072). A written agreement for F.O.R.U.M.'s services is currently being negotiated. No payment shall be made to F.O.R.U.M. prior to the execution of the written agreement. The authority granted herein shall automatically rescind in the event a written agreement is not executed within 60 days of the date of this Board Report. Information pertinent to this agreement is stated below.

This amendment is necessary to reduce the original term so that the term expires June 30, 2005, to reduce the aggregate value of this Agreement by \$246,624.00, and to amend the Scope of Services. A written amendment document is being prepared. The authority granted herein shall automatically rescind in the event a written document is not executed within 90 days of this amended Board Report.

TERM: The term of this agreement shall commence on the date the agreement is signed and shall end June 30, 2005 ~~36 months thereafter~~, with no services provided during the months of July and August of each year.

EARLY TERMINATION RIGHT: The Board shall have the right to terminate the agreement with 30 days prior written notice.

SCOPE OF SERVICES: FORUM will provide a Thematic Curriculum to students and parents in the S.M.A.R.T. Program. The curriculum shall focus on the importance of character development, decision making, substance abuse, and healthy life skills to CPS students who have violated CPS's Uniform Discipline Code, Section 5 and/or 6. F.O.R.U.M. will provide educational and interactive training activities to Elementary Students (grades 6-8) and High School Students (grades 9-12) which activities are intended to reduce the likelihood of students engaging in further drug use and gang activities. Students will be involved in weekly group sessions in ~~(3) nine-week cohorts~~ where they will engage in role-play, small interactive group sessions, and drug and gang prevention activities.

F.O.R.U.M. will provide parents with three, 4-hour workshops focusing on effective parenting skills, home development, and parental leadership.

DELIVERABLES: Each year of the Term Consultant will deliver the following, as requested: a) Three or Four nine-week 4-hour workshops for students who have violated CPS Uniform Discipline Code sections 5 and 6, related to drug and alcohol use and/or possession (not selling or distribution) and other nonviolent offenses; b) Pre-Posts test (Project Chances) results two weeks following each nine-week cohort; c) Three 4-hour parent workshops; d) Pre-Post test Parent Survey results two weeks following the each three week parent workshops; e) An ~~evaluation~~ report including an analysis of student and parent outcomes and satisfaction at the end of each nine-week cohort; f) ~~Biweekly and monthly~~ Periodic meetings with CPS Program Coordinators; g) ~~2 to 3~~ CPS One Staff Development In-Services; h) A Summary Report following the end of the academic year including internal evaluation results, an analysis protocol comparing each cohorts attendance rate, student and parent outcomes and satisfaction, and an analysis of the program; i) Refreshments to students and parents; and j). A written evaluation of the program prepared by an independent evaluator jointly selected by the Board's Office of Specialized Services and Consultant.

OUTCOMES: Consultant's services shall result in a 30-40% increase in student and parent knowledge and understanding on issues related to family, substance abuse, and the CPS Uniform Discipline Code.

COMPENSATION: Consultant shall be paid following the completion of each 9-week Cohort. (First year: ~~\$576,285 in the aggregate Cohort 1- \$192,095, Cohort 2-\$192,095 and Cohort 3- \$192,095. Second year: \$564,905 in the aggregate. Cohort 1-\$212,397, Cohort 2-\$212,397 and Cohort 3- \$212,397. Third year: \$523,762 in the aggregate Cohort 1- \$232,700, Cohort 2- \$232,700 and Cohort 3- \$232,700.~~)

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written agreement and amendment. Authorize the President and Secretary to execute the agreement and amendment.

AFFIRMATIVE ACTION: This contract is in full compliance with the goals required by the Revised Remedial Plan for Minority and Women Business Enterprise Contract Participation (M/WBE Plan). The M/WBE participation goals for the contract include 36% total MBE, 22% total African American, 10%total Hispanic, 2% total Asian and 5% total WBE.


Indebtedness – The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to




