

**RESCIND BOARD REPORT 06-0628-RS107
RESOLUTION DESIGNATING PROPERTY FOR THE
CONSTRUCTION OF A NEW SOUTHSIDE AREA HIGH SCHOOL**

WHEREAS, the Board of Education of the City of Chicago (the "Board") is a body corporate and politic organized and existing under and by virtue of the provisions of the School Code, 105 ILCS 5/34-1 *et seq.*, as amended (the "Code"); and

WHEREAS, the Board exercises general supervision and jurisdiction over the establishment and maintenance of public schools and other educational facilities of the Board including playgrounds and other recreational facilities; and

WHEREAS, Section 5/34-20 of the Code authorizes the acquisitions of title to real estate, by purchase, condemnation or otherwise, for school purposes, such title to be held for the use and benefit of the Board in the name of the City of Chicago in Trust for the Use of Schools; and

WHEREAS, on June 28, 2006 the Board adopted Resolution No. 06-0628-RS107 designating the property described in Exhibit A for the future construction of new Southside area high school;

WHEREAS, the Board has determined that at this time the acquisition of the property described in Exhibit A is not required for school and other educational and recreational purposes.

NOW THEREFORE BE IT HEREBY RESOLVED by the Board of Trustees of the Board of Education of the City of Chicago as follows:

1. The property described in Exhibit A is not required for school and other educational and recreational purposes at this time.
2. The Board hereby rescinds Resolution 06-0628-RS107 designating for acquisition the property described in Exhibit A for school and other educational and recreational purposes.
3. This resolution is effective immediately upon its adoption.

LEGAL DESCRIPTION:

ALL OF THAT PART OF THE VACATED CENTRAL ADDITION TO SOUTH ENGLEWOOD, LYING SOUTH OF THE CENTER LINE OF 91ST STREET (IF EXTENDED), EAST OF THE C.R.I. & P. RAILROAD COMPANY RIGHT OF WAY, NORTH OF THE NORTH LINE OF 92ND STREET (IF EXTENDED) AND WEST OF THE WEST LINE OF GREEN STREET (FORMERLY HOUGH AVENUE), IN THE EAST ½ OF THE SOUTHEAST ¼ OF SECTION 5, TOWNSHIP 37 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY ILLINOIS TOGETHER WITH ANY AND ALL RIGHTS TO THE ADJOINING STREETS AND ALLEYS.
