

APPROVE THE PARTICIPATION OF JONES ACADEMIC MAGNET HIGH SCHOOL IN THE GERMAN AMERICAN PARTNERSHIP PROGRAM (G.A.P.P.) GERMAN EXCHANGE AND AUTHORIZE EXPENSES RELATED TO THE PROGRAM

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve the participation of Jones Academic Magnet High School in the German American Partnership Program (G.A.P.P.) German exchange and authorize expenses related to the program.

PROGRAM: In conjunction with its World Language Program, Jones Academic Magnet High School will send eighteen (18) students, who reflect the school's population, to Magdeburg, Germany, from June 5, 2001, to June 26, 2001. The program in language immersion and comparative cultures includes a nineteen-day exchange component in the city of Magdeburg, Germany. Host families are selected by exchange teachers taking every precaution to insure student security and safety. The trip will be followed by a two-day education travel component in Berlin. The Jones Academic Magnet High School students involved are enrolled in German II or German III. They will be accompanied by Ms. Amy L. Fritsch, German teacher, Ms. Kathleen Murzyn, Math/Tech teacher at Jones, and Michael Beck, CPS Substitute Teacher.

EDUCATIONAL VALUE/OUTCOMES: Students in the World Language Program at Jones Academic Magnet High School study a curriculum which focuses on a global perspective in education. The curriculum emphasizes oral fluency in foreign language and development of awareness of cultural differences. During the field extension of their classroom studies, students will have the opportunity to explore cultural institutions and historical sites as they experience language immersion and contemporary German life and culture. The Students and their teacher will attend classes provided by Hegel Gymnasium in Magdeburg, the partner school in this exchange. The students will have first-hand contact with German culture and daily experience using the German language for various purposes, as well as studying historical events in the locations where they occurred.

TRAVEL ARRANGEMENTS/TRIPS INFORMATION: Arrangements for this program are being made by the American Council for International Studies (ACIS), 10 S. 463 Windjammer, Naperville, Illinois 60564, phone number (630) 369-4055.

COST: The per pupil cost is \$2,000.00, which includes transportation, certain meals, hotel accommodations, and trip cancellation insurance. Health and accident insurance will be provided by the Board of Education. The cost will be paid by the individual participants and by donation.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 97-1217-PO1 ("Policy on Student Travel"), including proper ratio of students to adults. Touring students will be accompanied by three (3) Jones Magnet staff members: Ms. Amy L. Fritsch, (German teacher), Ms. Kathleen Murzyn (Math/Tech teacher), Mr. Michael Beck, (CPS Substitute Teacher).

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at Jones Academic Magnet High School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this trip.

AFFIRMATIVE ACTION: Not applicable.

LSC REVIEW: The Jones Academic High School Local School Councils approved the tour on December 14, 2000.

FINANCIAL: No cost to the Chicago Public Schools.

GENERAL CONDITIONS: Inspector General - Each party to this agreement hereby acknowledges that in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts - The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness - The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics - The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of the agreement.


