

**AMEND BOARD REPORT #00-1115-PR22 AMEND BOARD REPORT #00-0927-PR47  
RATIFY ENTERING INTO AGREEMENTS WITH VARIOUS AGENCIES FOR EARLY  
CHILDHOOD EDUCATIONAL SERVICES FOR THE DEPARTMENT OF EARLY CHILDHOOD**

**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Ratify entering into agreements with various agencies listed below to provide early childhood educational services for the Office of Language, Cultural, and Early Childhood Education at a cost not to exceed ~~\$9,170,000~~ **\$9,310,000**. Agencies were selected on a non-competitive basis pursuant to previous involvement in the State Pre-Kindergarten program. A written agreement for Agency services is currently being negotiated. The authority granted herein shall automatically rescind in the event a written document is not executed within 120 days of the date of this Board Report. Information pertinent to this agreement is stated below.

This amendment is required to 1) increase the number of children served for 10 existing vendors, 2) add 8 additional vendors to provide classroom services under this program, 3) increase the total dollar amount of this Board authority and increase the individual dollar amounts for certain vendors; and 4) to correct various agency names and vendor numbers as indicated.

This second amendment is required to increase the dollar amount of the contract with the Ounce of Prevention due to an increase in the number of children being served.

**TERM:** The term of each agreement will commence on July 1, 2000 and shall end June 30, 2001.

**SCOPE OF SERVICES:** The agencies will provide an early childhood educational twelve (12) month program consisting of a two and one-half hour program day, where children will be exposed to cognitive, language-based, gross and fine motor and social and emotional activities to stimulate their growth and development. Three and four year-old children meeting the eligibility requirement of the State Prekindergarten program will be enrolled in the agency programs and will then be assigned Board identification numbers.

**DELIVERABLES:** Agencies will submit monthly reports regarding attendance, enrollment and parental involvement to the Manager of Community Based Programs. Fiscal reports will be submitted after six months and again at the end of the program year.

**OUTCOMES:** An educationally sound preschool program will be provided in childcare facilities via Board funding. The participating children will be enabled to make a smooth transition into the Board's kindergarten program. This program also provides services for children in over-crowded neighborhoods where there is no space for pre-kindergarten services in Chicago Public Schools.

**COMPENSATION:** The agencies shall be paid in two installments. The first installment shall be paid upon signing of the contract and the second installment will be due after the first six months of the contract and upon review of expenditure reports, in the amounts stated above, with the aggregate, not to exceed ~~\$9,470,000~~ \$9,310,000.

**AUTHORIZATION:** Authorize the General Counsel to include other relevant terms and conditions in the written agreement. Authorize the President and Secretary to execute the agreement.

**LSC REVIEW:** The Local School Council approval is not applicable to this report.

**AFFIRMATIVE ACTION:** Vendors agree to comply with and be bound by the provisions of the Revised Remedial Plan for Minority and Women Business Enterprise Economic Participation (M/WBE Plan). The services and products to be delivered by this vendor are subject to the provisions of the Revised Remedial Plan for M/WBE Economic Participation. Every good faith effort will be made by this vendor to achieve compliance with the applicable goals.






