Services: External audit services.  
Current Status: Final agreement is with vendor for signature.
  6. 01-0221-PR30: Amend Board Report 01-0124-PR40; Amend Board Report 00-1220-PR35; Approve Entering into Agreement for the Purchase of Specialized Assistive Technology Adapted Equipment, Maintenance and Training Services  
Services: Purchase of assistive technology equipment, maintenance of the equipment and training services.  
Current Status: 19 of 20 agreements are signed. Outstanding agreement with TLC Multimedia is with vendor for signature.
  7. 01-0221-OP2: Approve Entering into a License Agreement with Hyde Park Jewish Community Center for the Use of Space at Kenwood Academy  
Services: Use of gymnasium and pool for summer camp program.  
Current Status: In negotiations.
  8. 01-0221-OP5: Approve Entering into a License Agreement with Crystal Realty Company for Use of Parking Lot at 2325-33 W. Cermak Road  
Services: Temporary parking for staff at Pickard School.  
Current Status: In negotiations.
  9. 01-0328-PR9: Ratify Exercising the First Option to Extend the Agreement with Unisource Worldwide  
Services: Supply of Continuous Form 3800 Paper  
Current Status: Agreement is with vendor for signature.

Services: Teacher training workshops and seminars.  
Current Status: Agreement is with vendor for signature.

1. 00-1115-OP1: Approve Entering into an Intergovernmental Agreement with the Chicago Park District and the Department of Planning & Development Regarding the Acquisition of Land and the Joint Development of Clark Park  
Services: Acquisition of land and joint development and use of 5.8 acres to the east of existing Clark Park  
Action: Rescind the Board Report in full. This transaction is still being negotiated and the terms of the final agreement will be substantially different from the terms contained in this Board Report. A new Board Report reflecting the final agreed upon terms will be generated at the conclusion of the negotiations.
2. 00-1115-OP2: Accept the Conveyance of Land from the Chicago Park District for the Construction of the New Dawes School and Approve Entering into an Intergovernmental Agreement with the Chicago Park District for the Shared Use of the New Dawes School Athletic Facilities  
Services: Acceptance of property from the Park District and shared usage agreement for the athletic facilities at the new school.  
Action: Rescind the Board Report in full. This transaction is still being negotiated and the terms of the final agreement will be substantially different from the terms contained in this Board Report. A new Board Report reflecting the final agreed upon terms will be generated at the conclusion of the negotiations.
