#### RESOLUTION

# REQUEST CITY COUNCIL TO CONVEY TO THE CHICAGO PUBLIC LIBRARY A PORTION OF THE PROPERTY AT ORIOLE PARK ELEMENTARY SCHOOL FOR THE PURPOSES OF CONSTRUCTING A NEW BRANCH LIBRARY

**WHEREAS**, the Board of Education of the City of Chicago (the "Board") is a body corporate and politic organized and existing under and by virtue of the provisions of the School Code, 105 ILCS 5/34-1 et seq., as amended; and

WHEREAS, the Board exercises general supervision and jurisdiction over the establishment and maintenance of public schools and other educational facilities of the Board including playground and other recreational facilities, and in particular that portion of land located at the corner of North Olcott and West Balmoral Avenues consisting of a running track, recreational field and parking lot located at Oriole Park Elementary School; and

WHEREAS, the Board has determined that the property described in Exhibit A is no longer necessary, appropriate, required for the use of, profitable to, or in the best interests of the Board of Education of the City of Chicago; and therefore, the Board of Education hereby requests, in writing, the City Council of the City of Chicago, as trustee holding title to said real estate to convey said real estate to the Chicago Public Library, which the Chicago Public Library has indicated is necessary and convenient for its use; and

WHEREAS, an agreement has been reached between the Board of Education of the City of Chicago and the Chicago Public Library for the transfer of this real estate.

### NOW THEREFORE BE IT HEREBY RESOLVED THAT:

- 1. Inasmuch as the said real estate owned by the Board of Education of the City of Chicago, with title held in the name of the City of Chicago In Trust For the Use of Schools, is no longer necessary, appropriate, required for the use of, profitable to, or in the best interests of the Board of Education of the City of Chicago, the Chicago Board of Education by a vote of not less than two-thirds of its full membership, hereby orders and requests in writing the City Council of the City of Chicago, as trustee holding title to said real estate, to convey said real estate more particularly described in Exhibit A to the Chicago Public Library.
- 2. The Board further authorizes and directs the General Counsel or her designee, for and on behalf of the Board, to take all necessary action to consummate the conveyance of the real property as described in Exhibit A.
- 3. This resolution is effective immediately upon its adoption.
