ORIGINAL AGREEMENT: The original agreement (authorized by Board Report 99-1117-PR23) is for a term commencing January 19, 2000 and ending July 31, 2000, in the amount of \$44,220.00, with the Board having two options to extend the agreement for additional one year periods. The original agreement was awarded pursuant to a duly advertised Request For Proposal (RFP) issued July 29, 1999. The first option was exercised and the agreement was extended for one year (authorized by Board Report 00-0823-PR38), in the amount of \$37,000.00, commencing August 1, 2000 and ending July 31, 2001.

OPTION PERIOD: The agreement is being extended for 1 year commencing August 1, 2001 and ending July 31, 2002.

OPTION PERIODS REMAINING: There are no option periods remaining.

SCOPE OF SERVICES: Consultant shall continue to provide the consulting and administrative services in the original agreement, including annual review of CPS Bloodborne Pathogens Exposure Control Plan. Consultant, during the option period shall also provide the following additional new services: perform 25 on site visits to CPS schools to audit the current CPS Bloodborne Pathogens Exposure Control Plan compliance and submit to the Bureau of Employee Health Services a summary with recommendations; perform audits of six employee training sessions presented by Smith-Kline Beecham and submit to the Bureau of Employee Health Services a summary with recommendations; provide an annual review of the CPS Bloodborne Pathogens Exposure Control Plan, with written revisions and summaries, and submit recommendations to the Bureau of Employee Health Services as specified in the original agreement.

DELIVERABLES: Consultant shall submit audit reports of 25 school sites and six employee training sessions, prepare a revised CPS Bloodborne Pathogens Exposure Control Plan with written revisions, summaries and recommendations. The revised plan shall be available on February 18, 2002 for distribution to all schools.

OUTCOMES: Consultant's services will result in the Chicago Public Schools complying with the Bloodborne Pathogens Standard which is a regulation of the Federal Occupational Safety and Health Administration and The Illinois Department of Labor.
