**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Approve payment to Chicago Area Black Pilots Association which provided consulting services to Stagg Elementary School from September 4, 2001 to May 31, 2002, in the amount of \$28,000.00. These services were rendered without prior Board approval and all services have been completed. Consultant was selected on a non-competitive basis because this is a continuing program. Consultant has provided services to the Chicago Public Schools for more than three (3) years.

**SCOPE OF SERVICES:** Chicago Area Black Pilots Association exposed students of the Stagg Elementary School grades 4 through 8 to careers in aviation/science. The focus of this exposure program was to prepare students to consider this field as a career choice, and included trips to Kennedy Space Center in Orlando Florida, Johnson Space Center in Huston, Texas, National Weather Service Station in Romeoville, IL, Argon Gas Company, and Fermi Science Laboratory both located in Illinois. The aeronautic knowledge included aerodynamics, structures, thermodynamics, quality control, calculating momentum, time, distance, speed and meteorology.

**DELIVERABLES:** Consultant provided instructions two (2) days per week, 6 hours each day and accompanied students and teachers on 8 field trips related to aviation/science.

**OUTCOMES:** Consultant's services resulted in an increase in aviation career awareness, an increase of 10% in science test scores, and improved student attendance.

**COMPENSATION:** Consultant shall be paid the sum of \$28,000.00.


**AFFIRMATIVE ACTION:** A review of Minority and Women Business Enterprise participation was precluded due to completed contract performance.






