

AMEND BOARD REPORT 01-1024-PR3
APPROVE EXERCISING THE OPTION TO EXTEND THE PRE-QUALIFICATION STATUS AND THE
CONTRACTS OF VARIOUS CONTRACTORS TO PROVIDE COMMUNICATIONS
WIRING/COMPONENT AND HIGH VOLTAGE INFRASTRUCTURE INSTALLATION SERVICES

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve exercising the option to extend the pre-qualification status and the contracts of the below identified contractors to provide Communications Wiring/Component and High Voltage Infrastructure Installation services to the Department of Operations in an amount not to exceed \$60,000,000 in aggregate. A written extension document for each contractor is currently being negotiated. No payment shall be made to any contractor during the option period prior to the execution of such contractor's written agreement. The authority granted herein shall automatically rescind as to each contractor in the event a written agreement is not executed by such contractor within ninety (90) days of the date of this Board Report. Information pertinent to these agreements is stated below.

The purpose of this amendment is to extend the term of each contract for an additional ninety (90) days. A Request for Qualification to pre-qualify vendors for communications wiring/component and high voltage infrastructure installation services was published on May 20, 2002 (Specification No. 02-250049). Responses to the Request for Qualification were received from forty (40) contractors. It has been determined that the Evaluation Committee will not complete its review of the contractor responses prior to the September 30, 2002 expiration of the current pre-qualified contractor agreements (Board Report 01-1024-PR3). Therefore, it is necessary to amend Board Report 01-1024-PR3 for ninety (90) days to enable the members of the Evaluation Committee to complete their review and to ensure that the wiring installation services needed by the Department of Operations will continue without interruption. The authority granted herein shall automatically rescind as to each contractor in the event a written amendment is not executed by such contractor within sixty (60) days of the date of this Board Report.

NAMES OF CONTRACTORS: (See Attached List)

ORIGINAL AGREEMENT: The original pre-qualification period and the agreements (authorized by Board Report 99-1117-PR6) are for a term commencing November 1, 1999 and ending September 30, 2001, with the Board having the option to extend the pre-qualification period for one additional one-year period. The original agreements were awarded pursuant to a public Request for Qualification process (Specification No. 98-260077.1).

OPTION TERM: The term of the pre-qualification period and each of the agreements is being extended for a period commencing October 1, 2001 and ending ~~September 30, 2002~~ December 31, 2002.

OPTION PERIODS REMAINING: There are no options remaining.

SCOPE OF SERVICES: Contractors will continue to provide the following services:

A. Communication Wiring

1. Low voltage communications wiring and component installation in support of Local Area Network/Wide Area Network (LAN/WAN) implementation.
2. Contractor may be required from time to time as the need arises to perform installations, network, infrastructure improvements and other associated work for various purposes.

B. High Voltage Infrastructure

1. LAN/WAN-associated electrical power distribution infrastructure installation.
2. Electrical service upgrade and distribution for identified facilities of the Board.
3. Contractor may be required from time to time as the need arises to perform installations, network infrastructure improvements and other associated work for various purposes.

DELIVERABLES: Contractors will continue to provide completed projects in conformance with the project construction bid documents and in a timely manner and within budget.

OUTCOMES: The services of these contractors will continue to result in the upgrade of the technology at CPS facilities.

COMPENSATION: The compensation payable to all contractors, in the aggregate, for this extension shall not exceed \$60,000,000. The cost associated herewith shall be reported to the Board on a quarterly basis pursuant to Board Rule 5-10.2.

USE OF THE PRE-QUALIFIED POOLS: The Department of Operations will cause bid solicitations to be sent to the pre-qualified contractors for the type of services needed. Bids will be awarded to a contractor pursuant to a Notice of Award issued by the Chief Purchasing Officer. All awards (and any change orders thereto) will be subsequently presented to the Board for ratification.

E-RATE AMERITECH LAN PROGRAM: This pre-qualified pool of contractors will continue to be utilized for those services associated with specific approved E-Rate commitments which will be managed by Ameritech and/or other Board approved entities. Contractors identified as performing E-Rate eligible work will enter into contracts directly with Ameritech, the Board's Program Manager for E-Rate projects.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written extension agreements. Authorize the President and Secretary to execute the extension agreements. Authorize the Chief Purchasing Officer to issue the Notices of Award connected with the Program.

AFFIRMATIVE ACTION: Pursuant to Section 6.2 of the M/WBE Plan, the aggregated alternative method of compliance is being utilized as an effective method of achieving M/WBE participation where participation would otherwise not be achievable. Total aggregated M/WBE participation will be monitored and reported on a quarterly basis.


Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of the agreement.


Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).


