

**AUTHORIZATION TO PURCHASE 4921 N. SAWYER FOR THE
CONSTRUCTION OF THE NEW ALBANY PARK MIDDLE SCHOOL**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Authorize the purchase of the property at 4921 N. Sawyer for the construction of the New Albany Park Middle School. The authority granted herein shall automatically rescind in the event a written agreement is not executed within 120 days of the date of this Board Report. DESCRIPTION: 2,926.4 square foot brick 2-flat with detached garage located on a 3,752 square foot lot in Albany Park. PIN 13-11-423-011.

PURCHASE PRICE: \$363,000.00 + \$5,000 Owners relocation + Moving

PURPOSE/USE: To acquire property for the construction of the New Albany Park Middle School.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written agreement. Authorize the President and Secretary to execute Agreement. Authorize the General Counsel to execute all ancillary documents required to administer or effectuate this agreement.


Conflicts: The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILSC 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness: The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics - The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time, shall be incorporated into and made a part of the agreement.


Contingent Liability-The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).




