PROGRAM: Eighth grade field trip to Washington D.C. from Sunday, May 19 to Friday, May 23 2003.

EDUCATIONAL VALUE/OUTCOMES: To familiarize our students with historical documents, monuments, landmarks and governmental officials which are studied in the Social Sciences curriculum throughout the year. Students will do a comparative study on what they have read vs. what they will see first hand. Students will be expected to keep a daily journal and upon return prepare and notate a 'booklet' of their experiences and sites visited.

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Educational Tours Inc. will provide the coach bus, bus drivers, hotel accommodations, meal arrangements, and security personnel necessary for the trip. The students will travel to and from Washington D.C. via a coach bus. Students will stay four nights at the Hyatt Fairlakes Hotel, Fairfax, VA.
