- **WHEREAS,** the Northside College Prep Academic Decathlon Team won the statewide event on March 8, 2003 at Macolm X College for the first time and will advance to the national competition in Erie, Pennsylvania; and
- WHEREAS, the Northside College Prep Academic Decathlon Team won first place in Division III at the national competition in April, 2003; and
- WHEREAS, the Northside College Prep Academic Decathlon Team were named "Rookie of the Year" for achieving the highest score out of all the new schools and placed 7<sup>th</sup> in the nation overall; and

- WHEREAS, each decathlete had to draw inferences, make predictions, evaluate hypotheses, identify cause and effect, make generalizations, think analytically and creatively; and
- WHEREAS, the Northside College Prep Academic Decathlon Team members comported themselves with dignity, grace and aplomb in each round.
