

**ADJUST ATTENDANCE AREAS FOR ALEXANDER GRAHAM BELL SCHOOL, JAMES C. COONLEY SCHOOL, AND AUDUBON ELEMENTARY SCHOOL**

**THE CHIEF EXECUTIVE OFFICER RECOMMENDS:**

Effective July 1, 2003, adjust attendance boundaries for Alexander Graham Bell School, located at 3730 North Oakley Avenue; James C. Coonley School, located at 4046 North Leavitt Street; and Audubon Elementary School, located at 3500 North Hoyne Avenue. Students currently attending these schools may continue to remain in these schools.

**DESCRIPTION:** These changes are necessary in order to provide a safer walk to and from school.

**Adjust Attendance Area Boundary for Alexander Graham Bell School**

*Grades kindergarten through eighth:*

Beginning at the North Branch of the Chicago River and Irving Park Road  
East to Lincoln Avenue  
Southeast to Waveland Avenue  
West to Leavitt Street  
South (excluding both sides of the street) to Addison Street  
West (excluding both sides of the street) to Bell Avenue  
South (excluding both sides of the street) to Cornelia Avenue  
West to North Branch of Chicago River  
North to starting point.

**Adjust Attendance Area Boundary for John C. Coonley School**

*Grades pre-kindergarten through eighth:*

Beginning at the North Branch of the Chicago River and Berteau Avenue  
East to Western Avenue  
North to Montrose Avenue  
East to Damen Avenue  
South to Berteau Avenue  
East to Wolcott Avenue  
South to Belle Plaine Avenue  
East to the C&NW Railroad  
South to Byron Street  
West to Lincoln Avenue  
Northwest to Irving Park Road  
West to the North Branch of the Chicago River  
North to starting point.

**Adjust Attendance Area Boundary for Audubon Elementary School**

*Grades kindergarten through eighth:*

Beginning at Western Avenue and Cornelia Avenue  
East to Bell Avenue  
North (including both sides of the street) to Addison Street  
East (including both sides of the street) to Leavitt Street  
North (including both sides of the street) to Waveland Avenue  
East to Wolcott Avenue  
South to the alley between Roscoe Street and Henderson Street  
West to Damen Avenue  
South to Belmont Avenue  
West to Western Avenue  
North to starting point.
