

**ADJUST ATTENDANCE AREAS FOR PAUL CUFFE MATH SCIENCE TECHNOLOGY ACADEMY,
FOSTER PARK SCHOOL, AND WALTER Q. GRESHAM SCHOOL**

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Effective July 1, 2003, adjust attendance boundaries for Paul Cuffe Math Science Technology Academy, located at 8346 South Racine Avenue; Foster Park School, located at 8530 South Wood Street; and Walter Q. Gresham School, located at 8524 South Green Street. Students currently attending these schools may continue to remain in these schools.

DESCRIPTION: These changes are necessary due to the opening of the new Cuffe School building, built to replace the existing facility.

The Comprehensive Student Assignment Plan, adopted by the Board of Education on January 22, 1982 (Board Report 82-12), states: "The Board will seek to eliminate overcrowded schools to the greatest extent practicable considering all circumstances."

 East to Bishop Street
 North to 82nd Street
 East to Aberdeen Street
 South to 85th Street
 West to Racine Avenue

 West to Loomis Boulevard
 South to 87th Street
 West to Ashland Avenue
 North to starting point

Adjust Attendance Area Boundary for Foster Park

Grades kindergarten through eighth:

Beginning at 83rd Street and Western Avenue
 East to Ashland Avenue
 South To 89th Street
 Southwest along the C.R.I. & P. Railroad to 91st Street and the Penn Railroad
 Northwest along the Penn Railroad to 87th Street
 West to Western Avenue
 North to starting point

Adjust Attendance Area Boundary for Gresham

Grades kindergarten through eighth:

Beginning at 81st Street and Aberdeen Street
East to Morgan Street
North to 80th Street
East to Sangamon Street
South to 83rd Street
East to Halsted Street
South to Vincennes Avenue
Southwest to CRI&P RR
South to 87th Street
West to Racine Avenue
North to 85th Street
East to Aberdeen Street
North to starting point
