

APPROVE THE PARTICIPATION OF LINCOLN PARK HIGH SCHOOL IN A LANGUAGE AND CULTURAL EDUCATIONAL TOUR OF SPAIN (MADRID-SALAMANCA-BARCELONA) AND AUTHORIZE TRAVEL EXPENSES RELATED TO THE PROGRAM

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve the participation of twenty-five (25) Lincoln Park High School students in a language and cultural tour of Spain (Madrid-Salamanca-do-Barcelona) from April 9, 2004 through April 16, 2004, and authorize travel expenses related to the program, if any.

PROGRAM: In conjunction with the international student population and the study of language and cultural, Lincoln Park High School will send 24 students of Spanish plus four chaperones and four teachers to selected cities in Spain.

EDUCATIONAL VALUE/OUTCOMES: Students will learn not only the cultural history, customs and traditions of Spain (Goal 18), but will also be immersed in the Spanish Language (Goal 4). All students are currently enrolled in Spanish. Students will have the opportunity to expand their knowledge of the Spanish language and the customs and history of Spain.

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Arrangements for this program are being made by EF Educational Tours. Participants will travel Continental Airlines, O'Hare airport to Madrid/Barcelona and back to O'Hare.

COST: The per pupil cost is \$1,490.00 which includes transportation, meals, hotel accommodations, health and accident insurance coverage, etc. The cost will be paid by the students.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travel"), including the proper ratio of students to adults.

Traveling with students will be Mr. Manuel Verdugo (teacher), Mrs. Elizabeth Villagomez (teacher), Mr. Francisco Borrás (teacher), Luzumaris Cruz (teacher), Mr. Callaghan (parent), Mrs. Callaghan (parent), and Dr. Dave Tam (parent).

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at Lincoln Park High School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.

AFFIRMATIVE ACTION: Not applicable.

LSC REVIEW: This activity was approved by the LSC for Lincoln Park High School on October 30, 2003.

FINANCIAL: No cost to the Chicago Public Schools.

GENERAL CONDITIONS:

Inspector General – Each party to any agreement shall acknowledge that in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted July 26, 1995 (95-0726-EX3), as amended from time to time shall be incorporated into and made a part of any agreement.

Ethics – The Board's Ethics Code adopted September 27, 1995 (95-0927-RU3), as amended from time to time shall be incorporated into and made a part of any agreement.

Contingent Liability – Any agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
