

**ADJUST THE ATTENDANCE AREAS OF THE PADEREWSKI LEARNING ACADEMY AND
CASTELLANOS ELEMENTARY SCHOOL**

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Effective July 1, 2004, adjust the attendance areas of the Ignace Jan Paderewski Learning Academy, located at 2221 S. Lawndale Avenue, and the Rosario Castellanos Elementary School, located at 2524 S. Central Park Avenue.

These changes will affect only newly enrolled students in each area as described below. Students currently attending Castellanos Elementary School that will no be residing in the Paderewski Learning Academy attendance area may have the option of transferring to Paderewski if they so choose.

A public hearing was held on May 18, 2004, at the Castellanos Elementary School accepting the proposed boundary changes.

DESCRIPTION: These changes are made necessary to reduce overcrowding at the Castellanos Elementary School.

Adjust the Attendance Area Boundary of Ignace Jan Paderewski Learning Academy (Unit 6930):

Grades kindergarten through eighth:

Beginning at Springfield Avenue and 19th Street
East to Lawndale Avenue
North to 18th Street
East to Central Park Avenue
South to the CB&Q railroad
Southwest to Pulaski Road
North to the CTA railroad
East to Springfield Avenue
North to starting point.

*Grades fourth through eighth:
(Grades pre-kindergarten through third grade attend Cardenas Elementary School)*

Beginning at the CB&Q railroad and Hamlin Avenue
Northeast to Trumbull Avenue and Cermak Road
East to Christina Avenue
South to 23rd Street
West to the starting point.

Adjust the Attendance Area Boundary of the Castellanos Elementary School (Unit 2510):

*Grades fourth through eighth:
(Grades pre-kindergarten through third grade attend Cardenas Elementary School)*

Beginning at Pulaski Road and the CB&Q railroad
Northeast to Hamlin Avenue and 23rd Street
East along 23rd Street to Christina Avenue
South to 26th Street
West to Millard Avenue
North to 25th Street
East to Hamlin Avenue
North to 24th Street
East to Pulaski Road
North to starting point.




