PROGRAM: An educational 5-day tour of Washington DC. from May 16-20, 2005.

EDUCATIONAL VALUE/OUTCOMES:

The purpose of this field experience is to:

- Provide pupils first hand experience about the working of the three branches of government in a democracy.
- Develop pupil understanding and appreciation of the responsibilities and rights of citizenship in a democracy.
- Further pupils' awareness of themselves and the possibilities of their own influence and contribution to society.
- Motivate pupils to further their education and develop their talents to better serve, themselves, their families, community, and Country.
- Give pupils a "real life" opportunity to develop skills individually and as a group, to set goals, develop action plans and strategies, make decisions and choices to accomplish goals.
- Enhance pupils' study of American History, and the U.S. Constitution.

COST: The per pupil cost is \$640 x 42 which includes transportation by bus, meals, hotel accommodations, health and accident insurance, admission fees, and chaperones. The costs will be paid by an allocation of \$10,000 from State Chapter One FUNDS and fund-raising activities so that no pupil would be excluded for financial reasons.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travel"), including proper ratio of students to adults.

Traveling with the students will be Spyridoula Manis (coordinator), Betty Anderson (teacher), Cynthia Lung (teacher), Sandra Wadington (teacher), Michael DUEWELL (teacher), James Menconi (Principal), Genaro Benetiz (Assistant Principal).

PARENTAL CONSENT: Written parental consent and release forms for each participating student are on file at James Monroe Elementary School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.




