PROGRAM: Our World Language Program at School of the Arts South Shore High School will send students to Paris, France from May 24, 2005 through June 1, 2005.

EDUCATIONAL VALUE/OUTCOMES: It is strongly believed that students learn a second language best when they are immersed in the language and culture. By traveling to Paris the students will have the opportunity to fully indulge in not only the French language, but also in the daily culture. This will be a great opportunity for the students to use everything that they have learned. The students will verbally, audibly, visually and kinesthetically learn through experience more about the language as a culture and not just as a spoken language. Overall we will give our students a life time opportunity to study a world language in a unique way; to be able to travel to a new place and discover the culture, heritage and way of living of those in a different country. During this voyage the students will have the opportunity to explore cultural institutions and historical sites as they experience language immersion and contemporary French lifestyles and culture. CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travei"), including proper ratio of students to adults.

Traveling with students will be Ms. Rejoyce Thrower (teacher), Ms. Donna Harris (teacher), Raelyn Riley (Assistant Principal), and Mr. Douglas Maclin (Principal).

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at School of the Arts High School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.

AFFIRMATIVE ACTION: Not applicable.

FINANCIAL: No cost to the Board.

GENERAL CONDITIONS:
