

**RESOLUTION APPROVING CHIEF EXECUTIVE OFFICER'S RECOMMENDATION TO
DISMISS PROBATIONARY APPOINTED TEACHERS**

WHEREAS, the Chief Executive Officer has recommended that the Board dismiss or non-renew for the 2005-2006 school year the 1,099 probationary appointed teachers listed on Attachment 1 and incorporated herein, and has provided a reason for this recommendation with respect to each of those probationary appointed teachers;

WHEREAS, the Chief Executive Officer reached a tentative agreement on May 4, 2005 with the Chicago Teachers Union, the bargaining representative for the probationary appointed teachers, over certain terms and conditions of their non-renewal/dismissal;

NOW, THEREFORE, BE IT RESOLVED,

1. The Board accepts the Chief Executive Officer's recommendation and dismisses the 1,099 probationary appointed teachers identified in Attachment 1 to this Resolution.
2. The Board hereby ratifies the Chief Executive Officer's May 13, 2005 notice of non-renewal to the 1,099 probationary appointed teachers identified in Attachment 1 to this Resolution.
3. The Board hereby approves and adopts the May 4, 2005 tentative agreement entered into between the Chief Executive Officer's designees and the Chicago Teachers Union by which:
 - a. The date of dismissal for probationary appointed teachers who receive notice of non-renewal is fixed as the first day of teacher attendance for the following school year for the term of the 2003-2007 collective bargaining agreement and any successor thereto.
 - b. Health and dental benefits for probationary appointed teachers who have received notice of non-renewal from the Chief Executive Officer are extended to August 31st of the year of non-renewal/dismissal.
 - c. Probationary appointed teachers who received notice of non-renewal, but who are reappointed on or before November 1st of the year of non-renewal/dismissal, shall not suffer a break in service for purposes of attaining tenure.
