

RESOLUTION APPROVING CHIEF EXECUTIVE OFFICER'S RECOMMENDATION TO LAY OFF PROBATIONARY APPOINTED TEACHERS

WHEREAS, the Chief Executive Officer has recommended that the Board lay off the probationary appointed teachers listed on Attachment 1 and incorporated herein, and has provided a reason for this recommendation with respect to each of those probationary appointed teachers;
