TERM: The term of this leave and reimbursement period will begin September 1, 2005 and will end August 31, 2006. Subject to Board approval, this leave may be extended for up to a twelve (12) month period under the same terms and conditions contained herein

SCOPE OF DUTIES: The teacher's duties will involve coordinating the work of Chicago Park District's Outdoor Classroom program as it relates to Chicago Public Schools and the Chicago Math & Science Initiative. This entails:

- Coordinating professional development for teachers and classrooms making use of CPD resources around select parks.
- Assisting and leading field trips to parks.
- Outreach to schools and teachers to explain the science education resources of the Chicago Park District.
- Assistance with the CPS Student Science fair at the school, area, and city level, including assistance with the City Science Fair clubs.
- Maintain frequent communication with the administration of the Chicago Math & Science Initiative.
- Other duties, as directed by the CPS Director of Science.

FINANCIAL: The Board will pay Angela Dumas full salary, benefits, pension payments and related expenses and the Chicago Park District will reimburse the Board for the full salary only after receiving the Board's quarterly invoices. Her salary is funded through a grant from ComEd Exelon to the Chicago Park District.
