**APPROVE THE PRE-QUALIFICATION STATUS OF AND APPROVE ENTERING INTO AGREEMENTS  
WITH VARIOUS PROVIDERS TO PROVIDE SOCIAL, EMOTIONAL AND EDUCATIONAL  
CONSULTING SERVICES**

**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Approve the pre-qualification status of and approve entering into agreements with various providers to provide Social, Emotional and Educational Consulting services for the Office of Specialized Services at a cost not to exceed ~~\$865,324.00~~ \$1,501,355.00 in the aggregate. Providers were selected on a competitive basis pursuant to a duly advertised Request for Qualification (Specification No. 04-250075). Written agreements for these Providers ~~are being negotiated~~ have been negotiated and are currently on file in the Law Department. No payment will be made to any Provider prior to the execution of that Provider's written agreement. The authority granted herein will automatically rescind as to each Provider in the event a written agreement for such Provider is not executed within 120 days of the date of this Board Report. Information pertinent to these agreements is stated below.

This amended Board Report is necessary to ~~increase the aggregate dollar amount of this program by \$265,324 due to the inclusion of the Alternative Safe School Program.~~ allocate funding for FY06. No written amendments are required to the agreements.

**TERM:** The term of each agreement will commence September 22, 2004, and will end August 31, 2007. Each agreement shall have two one (1) year options to renew.

**SCOPE OF SERVICES:** Each provider has been approved in a designated category or categories (see Exhibit A). The areas of service include the following:

**DELIVERABLES:** Vendors will provide evidence-based age-appropriate training and/or services

**OUTCOMES:** Services provided by the consultants will result in the following:

- 1. Increase in the students' social and emotional competence most directly linked to academic performance.
- 2. Establish proven social, emotional and educational practices that support academic instruction and reduce the referrals to special education.
- 3. Increase the availability of support services for students and their families in high needs areas.
- 4. Increase the capacity of CPS to provide training opportunities for school staff in high needs areas.

**COMPENSATION:** Each Provider will be paid a negotiated rate for services rendered, as detailed in each Providers Agreement; Compensation not to exceed ~~\$865,324.00~~ \$1,501,355.00 in the aggregate.

**AUTHORIZATION:** Authorize the General Counsel to include other relevant terms and conditions in the written agreements. Authorize the President and Secretary to execute the agreements. Authorize the Chief Specialized Services Officer to execute all ancillary documents required to administer or effectuate these student placements and agreements, including but not limited to the Nonpublic Facility Placement contracts required by ISBE.

**AFFIRMATIVE ACTION:** Pursuant to section 3.7 of the Revised Remedial Plan for Minority and Women Business Enterprise Contract Participation (M/WBE Plan) the majority of this contract is exempt from review because the participation goal provisions of the Plan will not apply to transactions where the twenty-two vendors are not-for-profit organizations. 




