**APPROVE AGREEMENTS WITH VARIOUS AGENCIES FOR**  
**EARLY CHILDHOOD EDUCATIONAL SERVICES**

**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Approve agreements with the various Agencies, listed on Exhibit A attached hereto to provide early childhood educational services for the Office of Early Childhood Education at a cost not to exceed ~~\$30,370,508~~ \$35,217,584 in the aggregate. Agencies were selected pursuant to proposals solicited from community agencies and evaluated based on past services and the ability to meet program guidelines and state requirements. A written agreement for each Agency's services is currently being negotiated. No payment shall be made to any Agency prior to the execution of such Agency's written agreement. The authority granted herein shall automatically rescind as to each Agency in the event a written document for such Agency is not executed within 120 days of the date of this amended Board Report. Information pertinent to these agreements is stated below.

Amendment of this Board Report is required to correct the dollar amounts for vendors, and to reflect the name change of Central Baptist Community Center to Kid's Hope United.

Amendment of this Board Report is required to: (i) increase the total not to exceed the amount by \$4,809,006; (ii) increase the compensation amount of the 14 existing Agencies; (iii) add fifteen (15) new Agencies; and (iv) delete Panda Montessori Academy, Inc. (#85) as an Agency. Written agreements for the 15 new Agencies are currently being negotiated and written amendments to the agreements for the 14 existing Agencies related to compensation are being prepared. No payment shall be made to any of the new Agencies and no increased payments shall be made to the existing Agencies prior to the execution of such Agency's written agreement or amendment, as applicable. The authority granted herein shall automatically rescind as to each Agency in the event their respective written agreement or amendment is not executed within 120 days of this amended Board Report.

**TERM:** The term of each agreement will commence on July 1, 2005 and shall end June 30, 2006. The term of each new agreement shall commence November 1, 2005 and shall end June 30, 2006.

**SCOPE OF SERVICES:** The Agencies will provide an early childhood educational twelve (12) month program consisting of a two and one-half hour program day, where children will be exposed to cognitive, language-based, gross and fine motor and social and emotional activities to stimulate their growth and development. Three and four year-old children meeting the eligibility requirements of the Community Partnership - Early Childhood Programs will be enrolled in the Agency programs and will then be assigned Board identification numbers.

**DELIVERABLES:** Agencies will submit monthly reports regarding attendance, enrollment and parental involvement to the Director of Community Partnership Programs. Fiscal reports will be submitted after six months and again at the end of the program year.

**OUTCOMES:** An educationally sound preschool program will be provided in childcare facilities via Board funding. The participating children will be enabled to make a smooth transition into the Board's kindergarten program. This program also provides services for children in over-crowded neighborhoods where there is no space for pre-kindergarten services in Chicago Public Schools.

**COMPENSATION:** The Agencies shall be paid in two installments. The first installment shall be paid upon signing of the contract and the second installment will be due after the first six months of the contract and upon review of expenditure reports, in the amounts stated on Exhibit A for each Agency, with the aggregate not to exceed ~~\$30,370,508~~ \$35,217,584.

**AUTHORIZATION:** Authorize the General Counsel to include other relevant terms and conditions in the written agreements and amendments. Authorize the President and Secretary to execute the agreements and amendments.

**LSC REVIEW:** Local School Council approval is not applicable to this report.

**AFFIRMATIVE ACTION:** Pursuant section 3.7 of the Revised Remedial Plan for Minority and Women Business Enterprise Contract Participation (M/WBE Plan) this contract is exempt from review because the agencies are not-for-profits.

Ethics - The Board of Education Ethics Code (95-0927-RU4) as adopted September 27, 1995, as amended on April 21, 1999 (99-0421-PO2), is hereby incorporated into and made a part of this Contract as if fully set forth herein.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability subject to appropriation in the subsequent fiscal budget(s).
