DENY RENAISSANCE 2010 CHARTER SCHOOL PROPOSALS

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

That the Board deny the Renaissance 2010 charter school proposals identified in Appendix A.

DESCRIPTION: In May, 2005, the Board made available a request for proposals to solicit responses from parties interested in starting schools under the Renaissance 2010 initiative. Proposals to operate a charter school were submitted to the Board on August 19, 2005. Proposals were evaluated pursuant to the standards set forth in the Board' Renaissance School Policy 05-1026-PO2. The Department of New Schools Development evaluated 57 Renaissance school proposals.

A public hearing to review all charter school proposals was held on October 3, 2005 in accordance with Illinois Charter Schools Law. The Renaissance 2010 charter school proposals indicated in Appendix A are hereby denied. Charter school proposals listed in Appendix B were previously withdrawn by the applicants.
