

**ADJUST ATTENDANCE AREA FOR EDWIN G. FOREMAN, LAKE VIEW, LINCOLN PARK,
CARL SCHURZ, CHARLES STEINMETZ & WILLIAM TAFT HIGH SCHOOLS
AND IMPLEMENT ASSISTED ENROLLMENT FOR PROSSER CAREER ACADEMY**

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

Adjust attendance boundaries for Edwin G. Foreman High School located at 3235 North Leclair Avenue, Lake View High School located at 4015 North Ashland Avenue. Lincoln Park High School located at 2001 North Orchard Street; Carl Schurz High School located at 3601 North Milwaukee Avenue Charles P. Steinmetz High School, located at 3030 North Mobile Avenue and William H. Taft High School, located at 6530 West Bryn Mawr Avenue. Implementation of Assisted Enrollment for Prosser Career Academy located at 2148 North Long Avenue.

A Public Hearing was held on November 17, 2005 at the Board Offices located at 125 S. Clark discussing the proposed grade and boundary changes.

DESCRIPTION:

These changes are necessary to more evenly distribute utilization rates between Edwin G. Foreman, Lake View, Lincoln Park, Carl Schurz, Charles P. Steinmetz, and William Howard Taft High Schools. Foreman, Steinmetz and Taft are overcrowded high schools while Lakeview and Schurz has excess capacity. All of these schools have adjacent attendance boundaries. Assisted enrollment by the Department of School Demographics and Planning will also be implemented at Prosser Career Academy to further aid in relieving overcrowding at these schools.

The Modified Desegregation Consent Decree entered on March 1, 2004 by the U.S. District Court for the Northern District of Illinois in U.S. v. Chicago Board of Education, 80 C 5124 states; "CPS shall alleviate any racially and ethnically disproportionate overcrowding of school sites, to the extent practicable." Modified Consent Decree at Section I(G)(1), p. 9.




