PROGRAM: The MiCES, Inc. Paris 2006 trip is an educational trip abroad in which students will continue their studies of the French language and culture. Students will spend 7 nights in Paris and 8 days in Paris during Spring Break. The Program will focus on students' further enhancement of their literacy skills and cultural knowledge through a series of museum visits, monumental tours and general immersion on the language and culture of Paris.

EDUCATIONAL VALUE/OUTCOMES: The program is designed as such as students will be able to put to practical use the information they have been studying in class. The students will develop their own itinerary based on information given in class and research done online and in the library. This will allow students to take an active role in this program instead of being a passive tourist. A general itinerary would be as follows: April 7th: arrive in Paris in the afternoon, check into hotel, explore the Latin Quarter and view the city from the top of the Arc de Triomphe at night; April 8th: Morning guided tour of the Louvre; afternoon shopping on the Champs-Elysées; evening bus tour of city; April 9th: Morning guided tour of the Musée d'Orsey; afternoon return to the Latin Quarter to explore La Sorbonne; evening visit to Notre-Dame; April 10th: day trip to Giverny; April 11th: morning and afternoon in Monmartre to visit Sacre Coeur and explore the artist quarter; evening spent on Rue de la Huchette; April 12th: Visits to Rodin Museum, Napoleonic Museum and the Catacombes; students have a free afternoon to finish shopping at the Galleries Lafayette; April 13th: Day at Versailles; evening visit to top of the Eiffel Tower; April 14th: return to Chicago.
