**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Approve the participation of sixteen (16) Northside College Preparatory High School students in an educational tour to in Tokyo, Japan from April 8<sup>th</sup>-April 16, 2006 and authorize travel expenses related to the program if any.

**PROGRAM:** A study abroad trip to Japan for the students at Northside College Preparatory High School from April 8 through April 16, 2006.

**EDUCATIONAL VALUE/OUTCOMES:** The program, an international travel and study, is committed to ensuring cultural understanding through the Global Initiatives, a variety of educational experiences. The purpose is to expose students to cultural differences from their own, to expand awareness of the concept of the global community, to increase world understanding through indigenous experiences, to enhance language skills, to promote world peace through tolerance of differences, and to facilitate curricular concepts and cross-cultural connections. To this end, Northside College Preparatory study abroad program have been designed, thus the trip to Japan is proposed and planned.

**TRAVEL ARRANGEMENTS/TRIP INFORMATION:** Arrangements for this program are being made by IACE Travel, 350 Golf Road, Arlington Heights, IL. 60005. Contact phone (847)437-2244. Website: [www.iace-usa.com](http://www.iace-usa.com). The trip includes visit to Tokyo-the Capital as well as historical and cultural center of Japan. Moreover, home-stay will be provided in Gunma, which is located north of Tokyo by Oizumi International Association. The dates for the trip are from April 8 to April 16, 2006 during the CPS' spring break.

**COST:** The per pupil/person cost is \$ 1,850.00 which includes international and internal transportation, meals, hotel, health and accident insurance, trip cancellation insurance, entertainment, etc. Student's family will pay the costs. No cost to Chicago Public Schools.

**CHAPERONES:** Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travel"), including proper ratio of students to adults. Traveling with the students will be Leon Lim (teacher), Jeung-Hee Park (teacher) and Ms. Thea Lim (parent).

**PARENTAL CONSENT:** Written parental consent and release forms for each student are on file at Northside College Preparatory High School.

**AUTHORIZATION:** Authorize the President and Secretary to execute any travel agreements necessary for this program.

**AFFIRMATIVE ACTION:** Not applicable.

**LSC REVIEW:** Local School Council approval is not applicable to this report.

**FINANCIAL:** No cost to the board.

**GENERAL CONDITIONS:**

Inspector General – Each party to any agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – Any agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one-year period following expiration or other termination of their terms of office.




