

**APPROVE THE CANCELLATION OF CONTROLLED ENROLLMENT AT THE FOLLOWING SIXTEEN ELEMENTARY SCHOOLS: GEORGE ARMSTRONG; DANIEL CAMERON; CHARLES CARROLL-ROSENWALD; DURKIN PARK; FREDERICK FUNSTON; HELGE HAUGAN; EDWARD HURLEY; JORDAN COMMUNITY; MILDRED LAVIZZO; LESLIE LEWIS; JOSEPH LOVETT; FRANCES MCKAY; FLORENCE NIGHTINGALE; ADAM CLAYTON POWELL; EDWARD WHITE CAREER ACADEMY; AND ELI WHITNEY**

**THE CHIEF EXECUTIVE OFFICER RECOMMENDS:**

Approve the cancellation of controlled enrollment at Armstrong located at 2110 W. Greenleaf Avenue, Cameron located at 1234 N. Monticello Avenue, Carroll-Rosenwald located at 2929 W 83<sup>rd</sup> Street, Durkin Park located at 8445 S. Kolin Avenue, Funston located at 2010 N. Central Park Avenue, Haugan located at 4540 N. Hamlin, Hurley located at 3849 W. 69<sup>th</sup> Place, Jordan Community located at 7414 N. Wolcott Avenue, Lavizzo located at 138 W. 109<sup>th</sup> Street, Lewis located at 1431 N. Leamington Avenue, Lovett located at 6333 W. Bloomingdale Avenue, McKay located at 6901 S. Fairfield Avenue, Nightingale located at 5250 S. Rockwell Street, Powell located at 7530 S. South Shore Drive, White Career Academy located at 1136 W. 122<sup>nd</sup> Street, and Whitney located at 2815 S. Komensky Avenue effective July 1, 2006.

Public Hearings were held on February 23, 2006 and February 24, 2006 at the Board Offices located at 125 S. Clark discussing the proposed cancellation.

**DESCRIPTION:**

Approve the cancellation of controlled enrollment pursuant to the Board's policy "Controlled Enrollment of Elementary and High Schools" 04-0526-PO3. "At the end of each school year, the Office of Instruction and School Management together with the Department of School Demographics shall review the enrollment situation of all controlled enrollment schools and will evaluate whether controlled enrollment status continues to be appropriate."

The reviews and evaluations are complete and the Office of Instruction and School Management together with the Department of School Demographics finds that controlled enrollment status no longer continues to be appropriate for these schools. Based on this annual evaluation, the Chief Education Officer has recommended that these schools be removed from controlled enrollment status.


These schools will be staffed according to the ratios in the Agreement between the Board of Education of the City of Chicago and the Chicago Teachers Union.




