PROGRAM: An economic and cultural study abroad trip to Romania for the students at Dunbar Vocational Career Academy from May 20 through May 29, 2006. This is part of an ongoing economic partnership with a Romanian classroom where students have worked on cooperative economics projects. Students and teachers will stay with host families in Sibiu and youth residences and hotels in Bucharest, Brasov and Sighisora.

EDUCATIONAL VALUE/OUTCOMES: The purpose of this excursion is to give students the opportunity to study economics in a post-communist country that is working on establishing the principles of capitalism. The students will gain insight on the application of macroeconomics theories by working with a team of Romanian students on a collaborative project and interviewing Romanian business owners, students, consumers, and economists.
