

**RESOLUTION APPROVING CHIEF EXECUTIVE OFFICER'S RECOMMENDATION  
TO DISMISS/NON-RENEW PROBATIONARY APPOINTED TEACHERS BEFORE THE START OF  
THE 2006-2007 SCHOOL YEAR**

**WHEREAS**, the Chief Executive Officer has recommended that the Board dismiss or non-renew for the 2006-2007 school year the 1062 probationary appointed teachers listed on Attachment 1 and incorporated herein, and has provided a reason for this recommendation with respect to each of those probationary appointed teachers;

**NOW, THEREFORE, BE IT RESOLVED,**

1. The Board accepts the Chief Executive Officer's recommendation and dismisses the 1062 probationary appointed teachers identified in Attachment 1 to this Resolution effective August 29, 2006.
2. The Chief Executive Officer will deliver notices of dismissal or non-renewal to the 1062 probationary appointed teachers listed on Attachment 1 to this Resolution as soon as practicable after adoption of this Resolution.
3. Pursuant to the May 4, 2005 agreement between the Board and the Chicago Teachers Union (approved in Board Resolution # 05-0525-RS10) :
  - a. The date of dismissal for probationary appointed teachers who receive notice of non-renewal is fixed as the first day of teacher attendance for the following school year for the term of the 2003-2007 collective bargaining agreement and any successor thereto. Accordingly, said probationary appointed teachers shall be dismissed effective August 29, 2006.
  - b. Health and dental benefits for probationary appointed teachers who will receive notice of non-renewal from the Chief Executive Officer are extended to August 31, 2006, provided that the probationary appointed teacher makes required employee contributions.
  - c. Probationary appointed teachers who receive notice of non-renewal pursuant to this resolution, but who are reappointed on or before November 1, 2006, shall not suffer a break in service for purposes of attaining tenure.
