

**APPROVE EXERCISING THE OPTION TO RENEW THE AGREEMENT
WITH PETER CUNNINGHAM**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve exercising the option to renew the agreement with Cunningham Communications to provide consulting services to the Office of Communications at a cost for the option period not to exceed \$120,000. A written document exercising this option is currently being negotiated. No payment shall be made to Consultant during the option period prior to the execution of the written document. The authority granted herein shall automatically rescind in the event a written document is not executed within 90 days of the date of this Board Report. Information pertinent to this option is stated below.

ORIGINAL AGREEMENT: The original Agreement (authorized by Board Report #05-0622-PR12) in the amount of \$120,000, is for a term commencing July 1, 2006 and ending June 30, 2007, with the Board having two options to renew for one year periods. The original agreement was awarded on a competitive basis pursuant to Board Rule 5-4.1.

OPTION PERIOD: The term of this agreement is being extended for one year(s) commencing July 1, 2006 and ending June 30, 2007.

OPTION PERIODS REMAINING: There is one option period for one year remaining.

SCOPE OF SERVICES: Consultant shall continue to provide advice and consultation to the Office of Communications on the following matters: development of CPS' overall strategic communications plan, including, but not limited to organizational structure, development of CPS messages pertaining to key initiatives and preparation of customary public and media relations materials related to key initiatives. Consultant shall provide related direction and support to current communications staff.

DELIVERABLES: Consultant will continue to deliver periodic public and media relations materials and periodic status reports regarding the progress and performance of the Chief Executive office.

OUTCOMES: Consultant's services will result in a strategic communications plan and refinement of the CPS communications function.

COMPENSATION: Consultant shall be paid during this option period as follows: \$10,000 per month, not to exceed the sum of \$120,000.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written option document. Authorize the President and Secretary to execute the option document. Authorize the Chief Executive Officer to execute all ancillary documents required to administer or effectuate this option agreement.

AFFIRMATIVE ACTION: The M/WBE goals for this contract include: 26% total MBE & 5% total WBE. However, the Waiver Review Committee recommends that a full waiver of the M/WBE participation goals for this contract as required by the Revised Remedial Plan be granted because the contract is not further divisible.

LSC REVIEW: Local School Council approval is not applicable to this report.

GENERAL CONDITIONS:

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board member during the one year period following expiration or other termination of their terms of office.






