

**APPROVE THE ASSIGNMENT OF THE CHERRYROAD GROUP INC. (F/K/A CHERRYROAD TECHNOLOGIES INC.) CONTRACT TO CHERRYROAD TECHNOLOGIES INC.**

**THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:**

Approve the assignment of the CherryRoad Group Inc. (f/k/a CherryRoad Technologies, Inc.) contract to its subsidiary, CherryRoad Technologies, Inc. This contract, awarded under Board Report No. 05-1116-PR16 on a competitive basis pursuant to Board Rule 5-4.1, was for a two-year term commencing January 1, 2006 and ending December 31, 2008. CherryRoad Technologies, Inc. changed its name to The CherryRoad Group Inc. and The CherryRoad Group Inc. reorganized its corporate structure and created a new wholly-owned subsidiary, CherryRoadTechnologies, Inc. to break out the Enterprise Solutions operations from the parent holding company. A written assignment and assumption agreement to assign the contract and pricing schedule of The CherryRoad Group Inc. to its subsidiary, CherryRoad Technologies, Inc., is currently being prepared. 




