## RESOLUTION BY THE BOARD OF EDUCATION OF THE CITY OF CHICAGO REGARDING THE REMOVAL AND REPLACEMENT OF THE PRINCIPAL OF MARSHALL METRO HIGH SCHOOL AND THE TERMINATION OF THE PRINCIPAL'S CONTRACT

WHEREAS, the Illinois School Code grants the Board authority to establish guidelines to determine the factors for placing an attendance center on probation (105 ILCS 5/34-8.3(b));

WHEREAS, pursuant to such statutory authority, in April 2003, the Board adopted an accountability policy for all Chicago Public Schools, 03-0423-PO03 and then in, February 2004, adopted a revised accountability policy for all Chicago Public Schools, 04-0225-PO3;

WHEREAS, the Illinois School Code further provides that when a probation school fails to make adequate progress to correct deficiencies within one year, the Chief Executive Officer, with the approval of the Board and after an opportunity for a hearing, may remove and replace the probation school's principal (105 ILCS 5/34-8.3(d));

**WHEREAS**, pursuant to Section V of the Board's Uniform Principal's Performance Contract, a principal's contract may be terminated before the expiration of its four-year term based upon the principal's removal pursuant to Section 5/34-8.3(d);

WHEREAS, a hearing was held on July 6, 2006, to consider whether the principal of Marshall Metro High School, Dr. Gwendolyn Boyd, should be removed due to the school's failure to make adequate progress in correcting its academic deficiencies;

WHEREAS, an independent hearing officer has submitted a written report to the Chief Executive Officer summarizing all relevant evidence offered during the hearing, making findings of fact and recommending the removal of the Marshall Metro principal;

WHEREAS, the Chief Executive Officer has reviewed the Hearing Officer's findings of fact and recommendation and has recommended that Dr. Gwendolyn Boyd be removed and replaced as the principal of Marshall Metro High School and that Dr. Boyd's four-year principal's contract be terminated;

**WHEREAS,** Dr. Gwendolyn Boyd submitted a written statement to the hearing officer to contest her removal as principal of Marshall Metro; and

WHEREAS, it is the opinion of the Board of Education of the City of Chicago that it is in the best interests of the Chicago Public Schools to remove and replace Dr. Gwendolyn Boyd as principal of Marshall Metro High School and to terminate Dr. Boyd's principal's contract;

**NOW THEREFORE**, be it resolved by the Board of Education of the City of Chicago, as follows:

<u>Section 1</u>: After considering the recommendation of the CEO, as well as the supporting findings of fact and recommendation of the hearing officer, and after a thorough review of the entire record of the principal removal hearing, that the Board of Education of the City of Chicago adopts the findings of the hearing officer and accepts the recommendation of the Chief Executive Officer.

<u>Section 2</u>: that Dr. Gwendolyn Boyd be removed and replaced as principal of Marshall Metro High School and her principal's contract be terminated effective August 23, 2006.

Section 3: This Resolution shall take full force and effect upon its adoption.

**THEREFORE**, this Resolution is hereby adopted by the members of the Board of Education of the City of Chicago on August 23, 2006.
