PROGRAM: To provide students with an educational enrichment beyond the classroom, Sandoval School will send twenty-one 7th grade students who reflect the school's racial/ethnic population to Panama City, Panama from March 19th through March 26th, 2007 during Track "A" intersession.

EDUCATIONAL VALUE/OUTCOMES: The Cultural Immersion Program is designed to help participants experience Panama through a broad range of exceptional, educational experiences, both in the classroom and onsite. It is the premise of the program that these benefits will be longstanding and far reaching in their impact on students, teachers and administrators. Each student will shadow an individual student at their respective grade level and the teachers, and other staff members will shadow staff at their level. The prescribed itinerary of school visits and field trips to sites of historical and cultural interest related to the curriculum will be followed.

TRAVEL ARRANGEMENTS/TRIP INFORMATION: Design and development for this program are being made by Belkis M. Santos, Ph.D., President and CEO of B. Santos Consulting Group, Inc. (312) 243-7210, in collaboration with the Chicago Public Schools Office of Language and Cultural Education and ground package arrangements are being made by Anna Royo, President of *Experience Panama*, a renowned destination management company (507) 214-2030.

COST: The per pupil cost is \$ 2,000.00 which includes transportation, meals, hotel, health and accident insurance coverage proving protection against bodily injury or death. Scholarships have been provided by fund-raising activities so that no student is excluded for financial reasons.

CHAPERONES: Supervision of students will be provided for this program pursuant to Board Report 03-0527-PO01 ("Policy on Student Travel") includes proper ratio of students to adults.

Traveling with the students will be Ms. Yesenia Carapia (7th grade Teacher), Mr. James Gniadek (7th grade Teacher), Ms. Wendy Guerra (7th grade Teacher), Ms. Kathleen Ann McLaughlin (7th grade Teacher), Ms. Dawn Ruff (Teacher), Mr. Jose Luis Illanes (Assistant Principal) and Dr. David Espinoza (Principal).

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at Sandoval School.
