**AMEND BOARD REPORT 06-1115-EX14**  
**DENY RENAISSANCE 2010 SCHOOL PROPOSALS**

**THE CHIEF EXECUTIVE OFFICER RECOMMENDS:**

That the Board deny the Renaissance 2010 school proposals identified in Appendix A.

**DESCRIPTION:** In May 2006 the Board made available a Request for Proposals to solicit responses from parties interested in starting schools under the Renaissance 2010 Initiative. Design Frameworks to operate new schools were submitted to the Board on July 6, 2006 and full Proposals were submitted September 5, 2006. Proposals were evaluated pursuant to the standards set forth in the Board's Renaissance 2010 School Policy 05-1026-PO2. The Office of New Schools evaluated 51 Renaissance school proposals.

Public hearings to review all school proposals were held November 6 - 9, 2006. The Renaissance 2010 school proposals indicated in Appendix A are hereby denied. School proposals listed in Appendix B were previously withdrawn by the applicants.

This January 2007 amendment is necessary to correct the list of school proposals denied on Appendix A. The Academy of Urban School Leadership was included by error, as its Performance School proposal was approved under Board Report 06-1115-EX8.
