PROGRAM: This program will consist of ten days in Italy. The trip starts in Piacenza, Italy where they will visit with students from the "Liceo Resphigi". The Italian students will host the Payton students for meals and day trips. They will travel to Rome where they will participate in extensive tours of archeological sites. The students selected in the program have been studying Italian and participated in the Italian Seminar at Walter Payton College Prep High School.

EDUCATIONAL VALUE/OUTCOMES: It is to give the students an opportunity to meet the students from the "Liceo Respigi", whom they have connected with via e-mails and video-conference. They will be able to use their basic Italian during these meetings that they have learned. As Italian Seminar students they will have a better chance to understand their global community and they will be able to explore the cities' art, architecture and culture of the Italian people during their 5 day education tour of Rome.

PARENTAL CONSENT: Written parental consent and release forms for each student are on file at Walter Payton College Prep High School.

AUTHORIZATION: Authorize the President and Secretary to execute any travel agreements necessary for this program.
