PROGRAM: In conjunction with Westinghouse Career Academy's vision (to prepare all students for post-secondary opportunities and/or employment) and SIPAAA Goal #3 (to improve students' learning climate with a particular emphasis on increasing post-secondary opportunities) we took one hundred (100) students to culminate school year activities. All students participated in a summer retreat to plan the school year, a spring retreat to review activities and plan the final school semester. This final retreat reviewed the 2006-07 school year, analyzed data (ACT/PSAE/SEQ), finalized senior activities, and completed preparation for life after high school. This was achieved through a series of workshops, activities, and student-lead interactions. The students utilized their classroom instruction focused on communication, presentation, and cooperative learning skills. The retreat provided students opportunities to expand their knowledge for preparedness of post-secondary plans.

EDUCATIONAL VALUE/OUTCOMES: Because of this retreat, our Westinghouse Career Academy students provided a legacy for the school and learning in understanding the power in executing post-secondary plans for themselves and the community. Our Westinghouse Career Academy students came away from this experience more confident and with an expanded understanding of themselves, post-secondary plans with a connection to their community. This was in alignment with the Westinghouse Career Academy's SIPAAA goal three.
