

AMEND BOARD REPORT 07-0822-PR22
APPROVE EXERCISING THE FIRST OPTION TO RENEW THE AGREEMENTS WITH VARIOUS PROVIDERS TO PROVIDE SOCIAL, EMOTIONAL AND EDUCATIONAL CONSULTING SERVICES (SEL #2)

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve exercising the first option to renew the agreements with various providers to provide Social, Emotional and Educational Consulting services to the Office of Specialized Services at a cost for the option period not to exceed ~~\$73,300.00~~ \$282,163.00 in the aggregate. A written renewal document exercising this option is currently being negotiated for each provider. No payment shall be made to any provider during the option period prior to the execution of such provider's written renewal document. The authority granted herein shall automatically rescind as to each provider in the event that a written document for such provider is not executed within 90 days of the date of this amended Board Report. Information pertinent to this option is stated below.

Additionally, one (1) of the original group of six providers is being deleted because CPS has opted not to exercise that provider's option to renew, as that provider was not utilized during the original term.

This amended Board Report is necessary to increase the maximum program costs during this option period from \$73,300.00 to \$282,163.00 in the aggregate. This amended Board Report also is necessary to reflect an increase in the appropriation of Title IV Safe and Drug Free Schools funds and a new appropriation of Federal-Department of Education, Safe Schools Healthy Students funds committed to this project.

ORIGINAL AGREEMENT: The original agreements (authorized by Board Report 05-0824-PR21) in the amount of \$637,000.00 in the aggregate are for a term commencing September 1, 2005 and ending August 31, 2007, with the Board having two (2) options to renew for periods of one year each. The original agreements were awarded on a competitive basis pursuant to a duly advertised Request for Qualifications (Specification No. 05-250018).

OPTION PERIOD: The term of each agreement is being extended for one year commencing September 1, 2007 and ending August 31, 2008.

OPTION PERIODS REMAINING: Each agreement has one option period of one year remaining.

SCOPE OF SERVICES: Each provider has been approved to furnish services in one or more designated categories as specified in attached Exhibit A. These categories include the following:

- Category A: Program Development**
- Category B: Professional Development**
- Category C: Effective Prevention**
- Category D: Effective Intervention**

Category E: Parent Involvement and Development

DELIVERABLES: Providers shall continue to provide evidence-based, age-appropriate training to CPS staff and services to CPS students.

OUTCOMES: Provider services shall result in the following:

1. Increased student social/emotional competencies.
2. Implementation of proven practices to promote social/emotional learning by CPS staff.
3. Increase availability of support services for students and their families in high need areas.
4. Increased capacity of CPS to provide training opportunities for school staff in high need areas.

COMPENSATION: Each Provider shall be paid a negotiated rate for services as detailed in each Provider's renewal agreement. Compensation shall not to exceed ~~\$73,300.00~~ \$282,163.00 in the aggregate for the one year extension term.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written renewal agreements and amendments. Authorize the President and Secretary to execute the renewal agreements and amendments. Authorize the Chief Specialized Services Officer to execute all ancillary documents required to administer or effectuate these renewal agreements and amendments.

AFFIRMATIVE ACTION: Pursuant to Section 5.2 of the 2007 Remedial Program for Minority and Women Owned Business Enterprise Participation in Goods and Services Contracts, a determination shall be made as to when transactions should be excluded from contract specific M/WBE goals. It has been determined that the participation goal provisions of the Program do not apply to transactions where the pool of providers includes not-for-profit organizations.

LSC REVIEW: Local School Council approval is not applicable to this report.

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board’s Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).


