APPROVE ENTERING INTO AGREEMENTS WITH VARIOUS AGENCIES
FOR EARLY CHILDHOOD EDUCATIONAL SERVICES

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into agreements with the agencies listed in Exhibit "A" to provide early childhood educational services to children from birth to age five and their families at a cost not to exceed the aggregate amount of \$94,000,000. Agencies were selected on a non-competitive basis pursuant to proposals solicited from community agencies and evaluated based on past services and the ability to meet program guidelines as mandated by the Illinois State Board of Education. Written agreements for agency services are being negotiated. No services shall be provided by any agency and no payment shall be made to any agency prior to the execution of each agency's written agreement. The authority granted herein shall automatically rescind as to each agency in the event a written agreement for such agency is not executed within 120 days of the date of this Board Report. Information pertinent to these agreements is stated below.

This Board Report is being amended to i) add thirty (30) additional agencies (numbers 150 -179 included in Exhibit A), ii) modify the compensation amount for other vendors as noted and iii) delete vendor # 89, Lutheran Family Mission, as they are no longer in business. Agreements for the new agencies are currently being negotiated. No services shall be provided by and no payment shall be made to any new agency prior to the execution of such agency's written agreement. The authority granted herein shall automatically rescind as to each agency in the event a written agreement for such agency is not executed within 120 days of the date of this amended Board Report.

This January 2008 amended Board Report is to i) add nineteen (19) new agencies (numbers 180 -198 included in Exhibit A), ii) increase the compensation amount for fourteen (14) agencies as noted and iii) delete Emmanuel Christian School (#157) and Global Alliance Preparatory Charter School (#161). Agreements for the new agencies are currently being negotiated. No services shall be provided by and no payment shall be made to any new agency prior to the execution of such agency's written agreement. Written amendments are required to increase the compensation for the nine (9) agencies. The authority granted herein shall automatically rescind as to each agency in the event a written agreement for such new agency and written amendments for the fourteen (14) existing agencies are not executed within 120 days of the date of this amended Board Report.

TERM: The term of each Agency Agreement shall commence on July 1, 2006 and shall end on June 30, 2008. These agreements shall have 3 options to renew for periods of 2 years each. The term of each agreement for all new agencies (numbers 150-179 on Exhibit A) shall commence on October 1, 2006 and shall end on June 30, 2008 and shall have the 3 options to renew for periods of 2 years each. The term of each agreement for all new agencies (numbers 180-198 on Exhibit A) shall commence on February 1, 2008 and shall end on June 30, 2008 and shall have 3 options to renew for periods of 2 years each.

EARLY TERMINATION RIGHT: The Board shall have the right to terminate each agreement with 30 days written notice.

SCOPE OF SERVICES: Agencies will provide year round full day early childhood educational programs, case management services, and/or parent education services. Educational programs must be developmentally appropriate and meet the needs of each child and family. The educational program must include activities which foster cognitive, language, physical, and social, creative, emotional and personal (self-help) development. Nutrition education as well as ethnic and cultural activities should be included in the program. Children meeting the eligibility criteria will be assigned CPS student identification numbers.

DELIVERABLES: Agencies will deliver appropriate educationally sound preschool and/or infant toddler programs to eligible children enrolled in child care agencies and/or case management and/or parent educational services to children and families eligible for prevention program services as describe by the Illinois State Board of Education.

OUTCOMES: At risk children will be better prepared to enter Kindergarten.

COMPENSATION: Agencies shall be paid as follows: Each Agency shall be paid the sum identified in their individual agreement upon invoicing; the sum of payments to all agencies shall not exceed \$94,000,000 over a two-year period. Payments will be distributed two times each year. The first payment shall be made upon execution of the contract; subsequent payments shall be due each February and August after all financial documents have been reviewed and approved.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written agreements. Authorize the President and Secretary to execute the agreements. Authorize the Chief Early Childhood Education Officer or the Deputy Chief Early Childhood Education Officer to execute all ancillary documents required to administer or effectuate the agreements.

AFFIRMATIVE ACTION: Pursuant to section 3.7 of the Revised Remedial Plan for Minority and Women Business Enterprise Contract Participation (M/WBE Plan) this contract is exempt from review for those agencies that are non-for-profit. For those agencies that are for profit, their M/WBE plans will be monitored in the aggregate with the minimum requirements of 26% MBE and 5% WBE participation.

Pursuant to Section 5.2 of the Remedial Program for Minority and Women Owned Business Enterprise Participation in Goods and Services contracts, a determination will be made as to when transactions should be excluded from contract specific M/WBE goals. It has been determined that the participation goal provisions of the Program do not apply to transactions where the pool of providers includes non-for-profit organizations. This pool includes not-for-profit organizations and is exempt from specific goals.

GENERAL CONDITIONS:

Inspector General- Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34 13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts- The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of or the letting of contracts to, former Board member during the one-year period following expiration or other termination of their terms of office.

Indebtedness - The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time shall be incorporated into and made a part of the agreement.

Ethics - The Board of Education Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).




