**APPROVE THE PURCHASE OF WIDE AREA NETWORK EQUIPMENT,
MAINTENANCE AND ASSOCIATED TRAINING FROM AT&T DATACOMM, INC. f/k/a
SBC DATACOMM, INC.-AN AFFILIATE OF AT&T CORP.**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve the purchase of Wide Area Network ("WAN") equipment, maintenance and associated training from SBC DataComm, Inc. ("SBC DataComm" or "Vendor") for the Office of Technology Services ("OTS") at a cost not to exceed \$104,099,450.00, of which \$82,073,632.00 is eligible for, and contingent upon, discounts in accordance with the guidelines and requirements of the Federal Government's Universal Services Program ("E-Rate"); at a cost to the Board not to exceed \$2,690,952.00 in FY04 and \$4,040,731.00 in FY05, for an aggregate cost to the Board not to exceed \$6,731,683.00. SBC DataComm is the provider of services that qualifies the Board for the negotiated discount on all Cisco purchases, which discount is currently 42.5% under that certain contract for a term commencing September 26, 2002 and ending September 25, 2004, with one (1) option to extend for a three (3) year period, between SBC DataComm and the Illinois Century Network ("ICN"), by its fiscal agent, Illinois Board of Higher Education, which contract was awarded pursuant to a competitive solicitation issued by ICN for the benefit of various governmental agencies (the "ICN Contract"). The ICN Contract has been extended through September 24, 2007. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these WAN services is effectuated via the issuance of a purchase order to SBC DataComm from the Board. No additional written contract is required for this matter. Information pertinent to this matter is stated below.

This amendment is necessary to extend the approval period of the purchase of the Cisco Local Area Network (LAN) equipment in order to take advantage of the discounts provided by the ICN contract for school system improvements for FY 05. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these LAN services is effectuated via the issuance of a purchase order to SBC DataComm from the Board. No written contract is required for this matter.

This second amendment is necessary to allow for the Board's participation in Year 5 of the E-Rate program and to increase the dollar amount of this purchase by \$4,686,677.00 of which \$3,963,973.00 is eligible for and contingent upon, discounts in accordance with the guidelines and requirements of the Federal Government's Universal Services program ("E-Rate"); at a cost to the Board not to exceed \$722,704.00 for the purchase, installation, and project management of E-Rate year 5 WAN upgrades. The funds for the above amount were previously authorized under Board Report 01-1219-PR23 which expired June 30, 2003. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these services is effectuated via the issuance of a purchase order to SBC DataComm from the Board. No written amendment is required for this matter.

This third amendment is necessary to allow for the Board's participation in Year 8 of the E-Rate program and to increase the dollar amount of this purchase by \$24,368,783.00 of which \$20,775,879.00 is eligible for and contingent upon, discounts in accordance with the guidelines and requirements of the Federal Government's Universal Services program ("E-Rate"); at a cost to the Board not to exceed \$3,592,904.00 for WAN equipment upgrades. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these services is effectuated via the issuance of a purchase order to SBC DataComm from the Board. No written amendment is required for this matter.

This fourth amendment is necessary to allow for the Board's participation in Year 9 of the E-Rate program and to increase the dollar amount of this purchase by \$23,572,687.00 of which \$17,893,492.00 is eligible

for and contingent upon, discounts in accordance with the guidelines and requirements of the Federal Government's Universal Services program ("E-Rate"); at a cost to the Board not to exceed \$5,679,195.00 for WAN equipment upgrades. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these services is effectuated via the issuance of a purchase order to SBC DataComm from the Board. No written amendment is required for this matter.

This fifth amendment is necessary to allow for the Board's participation in Year 10 of the E-Rate program and to increase the dollar amount of this purchase by \$21,976,689.00 of which \$15,954,653.00 is eligible for and contingent upon, discounts in accordance with the guidelines and requirements of the Federal Government's Universal Services program ("E-Rate"); at a cost to the Board not to exceed \$6,022,036.00 for network equipment upgrades. It is also necessary to amend to add installation, configuration, and project management services for school LAN system improvements, These services shall have a cost not to exceed of \$2,993,880.00, of which approximately \$2,543,880.00 is eligible for E-Rate discounts and the total cost to the Board shall not exceed \$450,000.00. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these services is effectuated via the issuance of a purchase order to SBC DataComm from the Board. No written amendment is required for this matter.

This sixth amendment is necessary to extend the approval period of the purchase of the Cisco Network equipment in order to take advantage of the discounts provided by the ICN contract for school WAN upgrades and system improvements for FY 07, to coincide with the new contract term of the ICN agreement from July 1, 2003 extended until December 24, 2007. These services shall have a cost not to exceed \$101,077,414.00, of which approximately \$82,073,632.00 is eligible for discounts and the total cost to the Board shall not exceed \$19,003,782.00. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these LAN services is effectuated via the issuance of a purchase order to SBC DataComm from the Board. No written amendment is required for this matter.

This seventh amendment is necessary to extend the approval period of the purchase of the Cisco Network equipment in order to take advantage of the discounts provided by the ICN contract for school WAN upgrades and system improvements for FY 09, to coincide with the new contract term of the ICN agreement from July 1, 2003 extended until March 31, 2008. No orders may be placed for Cisco Network Equipment until SBC DataComm submits a contractor disclosure form to the Board and the Board accepts the contract disclosure form. This amendment is also necessary to increase services by \$4,536,926.04 to add the cost of E-Rate Year 11. These services shall have a cost not to exceed \$105,614,340.04, of which approximately \$85,088,973.70 is eligible for discounts and the total cost to the Board shall not exceed \$20,525,366.04. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these LAN services is effectuated via the issuance of a purchase order to SBC DataComm from the Board. No written amendment is required for this matter.

This eighth amendment is necessary to correct the vendor name because the legal name has changed with the State of Illinois from "SBC Datacom, Inc." to "AT&T Datacomm, Inc. f/k/a SBC DataComm, Inc". No orders may be placed for Cisco Network Equipment until AT&T Datacomm, Inc. submits a contractor disclosure form to the Board and the Board accepts the contract disclosure form. The ICN Contract allows other governmental agencies to purchase under the ICN Contract; thus, the purchase of these LAN services is effectuated via the issuance of a purchase order to AT&T Datacomm, Inc. f/k/a SBC DataComm, Inc. from the Board. No written amendment is required for this matter.

TERM: These purchases shall be made during the period commencing July 1, 2003 through March 31, 2008, which end date is co-terminus with the end date of the ICN Contract. Provided the ICN Contract term is extended for an additional period, the Board shall continue to purchase through the ICN Contract, subject to Board approval. This term is necessary to coincide with, and allow for the Board's participation in, Year 5, Year 6, Year 7, Year 8, Year 9, Year 10, and Year 11 of the E-Rate program.

DESCRIPTION OF CISCO EQUIPMENT PURCHASE: Vendor will provide equipment for WAN and LAN hardware upgrades, enhancements and expansion. Equipment shall include, but not be limited to: Cisco system hardware, software and services (including but not limited to 6500 series switches, ESR Routers, CSS Switches, associated cables).

OUTCOMES: Vendor's services will result in improved WAN and LAN services and features, including maintenance and associated training, for the Chicago Public Schools. All schools will have the equipment necessary for a second T-1 connection to the Board's system, which will provide additional bandwidth and improved network performance. Aging LAN equipment at schools will be replaced with newer equipment providing greater network stability and improved LAN performance.

COMPENSATION: Vendor shall be paid as follows: upon invoicing, at the negotiated discounted rates as specified in the pricing formulas in the ICN Contract, which discount is currently 42.5%, for a cost not to exceed \$105,614,340.04, of which \$85,088,973.70 is eligible for E-Rate discounts; at a cost to the Board not to exceed \$2,690,952.00 in FY04, \$4,040,731.00 in FY05, \$3,592,904.00 in FY06, \$5,679,195.00 in FY07, \$3,000,000.00 in FY08, and \$1,521,584.34 in FY09 for an aggregate cost to the Board not to exceed \$20,525,366.04 for the six (6) year period.

AUTHORIZATION: No additional written contract is required for this matter. Authorize the Chief Information Officer to execute any ancillary documents required to administer or effectuate these purchases. Allow the Chicago Charter School Consortium, a consortium of charter schools who share facilities with CPS schools or reside at CPS owned facilities, to receive services from SBC Datacomm pursuant to this agreement.

AFFIRMATIVE ACTION: Exempt; the Board will be using the contract with the Illinois Board of Higher Education.

LSC REVIEW: Local School Council approval is not applicable to this report.

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.


Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one-year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.






