

**APPROVE ENTERING INTO A NATIONAL DEFENSE CADET CORPS PROGRAM WITH THE ARMY
JUNIOR RESERVE OFFICERS' TRAINING CORPS**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into an agreement with the Department of the Army, Headquarters, United States Army Junior Reserve Officers' Training Corps ("Army JROTC") for the operation of a National Defense Cadet Corps Program ("NDCC") at Roger C. Sullivan High School ("School"). The agreement shall incorporate: (a) Title 10, USC, Section 2031, Department of Defense Instruction 1205.13; (b) Army Regulation (AR) 145-2; (c) U.S. Army Cadet Command Regulation (CCR) 145-2; (d) Army Junior Reserve Officers' Training Corps Standing Operating Procedures; and (e) all other regulations of the Department of the Army and Headquarters US Army Cadet Command (USACC) relating to the conduct of the program. A written agreement is available for Board review and approval. Information pertinent to this agreement is stated below.

BACKGROUND: Dr. Joseph P. Atria, Principal, Roger C. Sullivan High School requested the establishment of a National Defense Cadet Corps (NDCC) program for school year 2008 - 2009.

TERM: The term of the agreement shall commence upon execution by both parties and remains in effect until it is terminated by the agreement of the parties.

PROGRAM DESCRIPTION: The Army JROTC will provide the Program which seeks to fulfill the following objectives;

1. Give students an appreciation of the origin, advantages and responsibilities of citizenship in our country.
2. Develop in students an understanding of good leadership skills and the advantages of strong moral character.
3. Promote in the students an understanding for the need and application of our national security.
4. Develop in students a sense of pride and personal discipline.
5. Teach students to understand and respect the need for constitutional authority as the foundation of a democratic society.

OUTCOMES: The Program will provide students with the opportunity to develop leadership skills, responsibility, self-confidence, self-esteem, physical fitness, citizenship, and a spirit of patriotism.

PROGRAM FUNDING: Chicago Public Schools will:

1. Provide for use of Government property and facilities as authorized by law to other AJROTC units.

2. Employ qualified instructors authorized and approved by the Commanding General, USACC to administer the military courses, at no expense to the Government (a minimum of one officer and one noncommissioned officer per unit).
3. Purchase 100% of NDCC uniforms and other Table Equipment items as required upon establishment of the NDCC unit.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written agreement. Authorize the President and Secretary to execute the agreement.

AFFIRMATIVE ACTION: Not Applicable.

GENERAL CONDITIONS:

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board member during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).

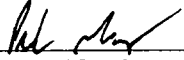

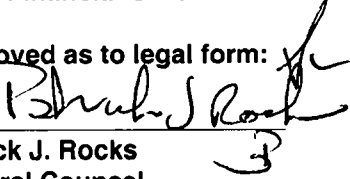
