

**APPROVE EXERCISING THE SECOND OPTION TO RENEW THE AGREEMENTS
WITH VARIOUS PROVIDERS TO PROVIDE SOCIAL, EMOTIONAL AND EDUCATIONAL CONSULTING
SERVICES (SEL #1)**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve exercising the second option to renew the agreements with various providers to provide Social, Emotional and Educational consulting services to the Office of Specialized Services at a cost for the option period not to exceed \$138,560.00 in the aggregate. A written document exercising this option is currently being negotiated. No payment shall be made to any provider during the option period prior to the execution of such provider's written renewal document. The authority granted herein shall automatically rescind as to each provider in the event that a written document for such provider is not executed within 90 days of the date of this Board Report. Information pertinent to this option is stated below.

The agreements with Advanced Systems and Planned Parenthood are not being renewed.

ORIGINAL AGREEMENT: The original Agreements (authorized by Board Report 04-0922-PR34) in the aggregate value not to exceed \$600,000.00 are for a term commencing September 22, 2004 and ending August 31, 2007, with the Board having two options to renew for periods of one year each. The first option period was for a term commencing September 1, 2007 and ending August 31, 2008 (authorized by Board Report 07-0822-PR21, as amended by Board Report 07-1117-PR21 and Board Report 08-0423-PR19). The original agreements were awarded on a competitive basis pursuant to a duly advertised Request for Qualifications (Specification Number 04-250075).

OPTION PERIOD: The term of each agreement is being extended for one year commencing September 1, 2008 and ending August 31, 2009.

OPTION PERIODS REMAINING: There are no option periods remaining.

SCOPE OF SERVICES: Each provider has been approved to furnish services in one or more designated categories (see Exhibit A). Services include the following:

Category A: Staff Development and Training

1. Classroom and School-Wide Behavior Management
2. Resiliency and Strength-Based Techniques
3. Human Sexuality
4. Emotional Intelligence
5. Social and Emotional Learning

Category B: Counseling and Student Workshops/Seminars

1. Mental Health Services
2. Trauma Management
3. Bullying
4. HIV and Aids

5. Gang Prevention
6. Peer Leadership
7. Violence Interruption
8. Female/Male Mentoring
9. Dating Violence Training
10. Gay and Lesbian Issues

Category C: Instructional Programs

1. Art Instruction
2. Drug Prevention
3. Character Education
4. Writing Literacy

Category D: Program Development

1. Female/Male Mentoring
2. Parent Involvement
3. Drug Prevention Education

Category E: Program Evaluation

DELIVERABLES: Providers shall continue to furnish evidence-based, age-appropriate training to Board staff and services to CPS students.

OUTCOMES: Provider services shall continue to result in the following:

1. Increased student social/emotional competencies.
2. Implementation of proven practices to promote social/emotional learning by Board staff.
3. Increased availability of support services for students and their families in high need areas.
4. Increased capacity of the Board to provide training opportunities for school staff in high need areas.

COMPENSATION: Each provider shall be paid a negotiated rate for services as detailed in each provider's renewal agreement. Compensation shall not exceed \$138,560.00 in the aggregate for the one year extension term.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written renewal agreements. Authorize the President and Secretary to execute the renewal agreements. Authorize the Chief Specialized Services Officer to execute all Statements of Work and amended Statements of Work, and all ancillary documents required to administer or effectuate these renewal agreements.

AFFIRMATIVE ACTION: Pursuant to Section 5.2 of the 2007 Remedial Program for Minority and Women Owned Business Enterprise Participation in Goods and Services Contracts, a determination shall be made as to when transactions should be excluded from contract specific M/WBE goals. It has been determined that the participation goal provisions of the program do not apply to transactions where the pool of providers includes Not-for-Profit organizations.

LSC REVIEW: Local School Council approval is not applicable to this report.

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.


Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board member during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.




