

**APPROVE EXERCISING THE FIRST OPTION TO RENEW THE PRE-QUALIFICATION STATUS OF
AND THE AGREEMENTS WITH ARCHITECTS/ENGINEERS OF RECORD TO PROVIDE
ARCHITECTURAL/ENGINEERING SERVICES**

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve exercising the first option to renew the pre-qualification status of vendors to provide Architectural and Engineering services at a cost during the extension period not to exceed \$12,200,000.00. Written extension agreements for each vendor are currently being negotiated. No payment shall be made to any vendor during the extension term prior to the execution of such vendor's written extension agreement. The authority granted herein shall automatically rescind as to each vendor in the event such vendor fails to execute the extension agreement with 120 days of the date of the Board Report. Information pertinent to this extension is stated below.

ORGINAL AGREEMENT: The original agreements (authorized by Board Report 06-0322-PR3), as amended (authorized by Board Report 08-0602-PR6) are for a term commencing three years, effective April 1, 2006 and ending March 31, 2009, with the Board having the right to extend the pre-qualification period and each master agreement for one additional one year period. The original agreements were awarded on a competitive basis pursuant to duly advertised Request for Qualifications (Specification No.: 05-250074).

RENEWAL TERM: The renewal agreements will commence April 1, 2009 and end March 31, 2010.

OPTION PERIOD REMAINING: There are no option periods remaining.

SCOPE OF SERVICES: The Architects and Engineers of Record will continue to manage and coordinate individual projects. The firms will be assigned to prepare design development documents, construction documents and specifications setting forth in detail the site-specific requirements for each project. In addition, each firm may also perform any or all of the following services: scheduling, budgeting, site analysis, coordinating CPS construction schedules with the applicable city agencies and solicitation and coordination of specialty consultants, such as geo-technical consultants, as they relate to individually assigned projects. These pre-qualified firms have the experience and the expertise in performing the required Architectural and Engineering services. Their organizational structure provides CPS with a high degree of confidence in their ability to meet the aggressive schedule found in the Capital Improvement Program. The services of these firms are needed to ensure that CPS capital spending for Capital Planning will best serve the needs of the Chicago Public School children and their surrounding communities.

COMPENSATION: The sum of payments to all pre-qualified vendors during the extension term shall not exceed the aggregate amount of \$12,200,000.00.

USE OF THE POOL: The Department of Facilities is authorized to receive services from the pre-qualified pool as follows: Vendors are assigned work based upon the vendors experience with the requirements of the jobs.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written renewal agreements. Authorize the President and Secretary to execute the renewal agreements. Authorize Chief Operating Officer to execute all ancillary documents required to administer or effectuate the renewal agreements.

AFFIRMATIVE ACTION: Pursuant to section 6.2 of the Revised Remedial Plan for Minority and Women Business Enterprise Economic Participation (M/WBE Plan), the Per Contract and Category Goals method for M/WBE participation will be utilized. Thus, contracts for vendors in the pool will be subject to compliance reviews on a contract-by-contract basis. Aggregated compliance of the vendors in the pool will be reported on a quarterly basis.

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.


Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board’s Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board’s Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).


