ADJUST THE ATTENDANCE AREAS OF CARPENTER, OTIS, OGDEN, AND TALCOTT ELEMENTARY SCHOOLS AND CHANGE THE GRADE STRUCTURE OF CARPENTER ELEMENTARY SCHOOL

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

That effective July 1, 2009, the attendance areas of Carpenter Elementary School (unit 2640, school ID 609838) ("Carpenter"), located at 1250 West Erie Street, James Otis Elementary School (unit 5220, school ID 610107) ("Otis"), located at 525 North Armour Street, William B. Ogden Elementary School (unit 5150, school ID 610101) ("Ogden"), located at 24 West Walton Street, and Talcott Elementary School (unit 6140, school ID 610197) ("Talcott"), located at 1840 West Ohio Street, be adjusted and changed and that the grade structure of Carpenter be changed as described below.

DESCRIPTION:

Currently, Carpenter serves kindergarten through eighth grade in addition to offering pre-kindergarten programs. Effective July 1, 2009, Carpenter will decrease its grade structure to serve grades first through eighth and, thereafter, Carpenter will decrease its grade offering by one grade per year (second through eighth). Students not yet enrolled in kindergarten who reside within the current Carpenter attendance area will be assigned to Otis or Ogden as of the 2009-2010 school year.

Pursuant to the Board of Education's Policy on the Review and Establishment of School Attendance Boundaries, 05-0622-PO1, a public hearing was convened on January 29, 2009, following the issuance of proper notice to receive public comment on the CEO's proposal to adjust the attendance area boundaries of Carpenter, Otis, Ogden, and Talcott and to adjust the grade structure of Carpenter due to reasons associated with space utilization. An independent hearing officer received comments and supporting documents at the hearing and kept the record open after the meeting to receive additional written comments or documentation. Transcripts of the public hearing have been provided to the Board. The hearing officer had prepared and submitted a report regarding the CEO's proposal in which the hearing officer recommends the adjustment of the attendance area boundaries of Carpenter, Otis, Ogden, and Talcott and the adjustment of the grade structure of Carpenter. After receiving the hearing officer's report, the CEO has determined to recommend that the Board approve the attendance area and grade structure adjustments effective July 1, 2009 and reassign Carpenter's attendance area to the Otis and Ogden elementary schools one grade per year from the 2009-2010 to the 2016-2017 school years.
