APPROVE ENTERING INTO AGREEMENTS WITH VARIOUS PROVIDERS
FOR HIGH QUALITY EARLY CHILDHOOD SERVICES

THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Approve entering into agreements with the providers listed in Exhibit "A" to provide high quality early childhood services to children ages birth to five and their families at a cost not to exceed the aggregate amount of \$55,710,000. Providers were selected on a non-competitive basis pursuant to submitted proposals and evaluated on past services and the ability to meet program guidelines as mandated by the Illinois State Board of Education and the Chicago Public Schools. Written agreements for services are being negotiated. No services shall be provided by any provider and no payment shall be made prior to the execution of such provider's written agreement. The authority granted herein shall automatically rescind as to each provider in the event a written agreement for such provider is not executed within 120 days of the date of this amended Board Report. Information pertinent to these agreements is stated below.

This August 2008 amended Board Report is necessary to add thirty (30) new agencies (numbers 144 -173 included in Exhibit A).

This April 2009 amended Board Report is necessary to add twelve (12) new agencies (numbers 174 -185 included in Exhibit A) and to adjust the aggregate amount to correctly reflect the FY09 budget. Written agreements with these new providers are required. No services shall be provided by any new provider and no payment shall be made to any new provider prior to execution of their written agreement. The authority granted herein shall automatically rescind as to each new provider in the event their written agreement is not executed within 120 days of the date of this amended Board Report.

This May 2009 amended Board Report is necessary to add four (4) new agencies (numbers 186 -189 included in Exhibit A). Written agreements with these new providers are required. No services shall be provided by any new provider and no payment shall be made to any new provider prior to execution of their written agreement. The authority granted herein shall automatically rescind as to each new provider in the event their written agreement is not executed within 120 days of the date of this amended Board Report.

TERM: The term of each Provider Agreement shall commence on July 1, 2008 and shall end on June 30, 2009. Each agreement shall have three (3) options to renew for periods of one (1) year each. The term of each agreement for all new agencies (numbers 144-173 on Exhibit A) shall commence on September 1, 2008 and shall end on June 30, 2009 and shall have three (3) options to renew for periods of one (1) year each. The term of each agreement for all new agencies (numbers 174-185 on Exhibit A) shall commence on May 1, 2009 and shall end on June 30, 2009 and shall have three (3) options to renew for periods of one (1) year each. The term of each agreement for all new agencies (numbers 186-189 on Exhibit A) shall commence on May 28, 2009 and shall end on June 30, 2009; and the agreements shall have three (3) options to renew for periods of one (1) year each.

EARLY TERMINATION RIGHT: The Board shall have the right to terminate each agreement with 30 days written notice.

SCOPE OF SERVICES: Providers may provide one or more of the following services: early childhood center based educational services in a full day setting for preschool children ages 3 and 4; infant – toddler center based education services (pre-school ages 3-4) in a full day setting for children ages birth to age 3; Prevention Initiative Model Services to children ages birth to age 3 and their families; or Parental Training services to families with

children under the age of 5 receiving no other educational services. Programs must be developmentally appropriate and meet the needs of each age group and their families. Center based educational programs must include a Research Based Curriculum with activities that foster cognitive, language, physical, social, creative, emotional and personal (self-help) development. Prevention Initiative and Parental Training programs must be designed so that parents will gain knowledge and skills in parenting through implementation of a research based program model which will guide the provision of services and provide for coordination of services.

DELIVERABLES: Providers will deliver appropriate educationally sound and research based preschool and/or infant toddler programs to eligible children enrolled in child care centers and/or case management and/or parent educational services to children and families eligible for the Prevention Initiative or Parental Training programs as described by the Illinois State Board of Education.

OUTCOMES: Young children will develop a strong foundation for learning and will be better prepared to enter preschool and kindergarten. At-risk children and families will have access to coordinated services and extra preparation prior to kindergarten.

COMPENSATION: Providers shall be paid as follows: Each provider shall be paid quarterly upon invoicing based upon budgets submitted and approved by the Board; the sum of payments to all providers shall not exceed \$55,710,000. Payments will be distributed four times each year. The first payment shall be made within 30 days of contract execution; subsequent payments shall be made during the months of October, January, and April after all financial and program information including budget, certification, enrollment, expenditure documents and reports have been reviewed and approved by the Board.

AUTHORIZATION: Authorize the General Counsel to include other relevant terms and conditions in the written agreements. Authorize the President and Secretary to execute the agreements. Authorize the Chief Early Childhood Education Officer or the Deputy Chief Early Childhood Education Officer to execute all ancillary documents required to administer or effectuate the agreements.

AFFIRMATIVE ACTION: Pursuant to Section 5.2 of the 2007 Remedial Program for Minority and Women Owned Business Enterprise Participation in Goods and Services Contracts, a determination shall be made as to when transactions should be excluded from contract specific M/WBE goals. It has been determined that the participation goal provisions of the Program do not apply to transactions where the pool of providers includes not-for-profit organizations.

GENERAL CONDITIONS:

Inspector General- Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34 13.1, the Inspector General of the Chicago Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts- The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of or the letting of contracts to, former Board members during the one-year period following expiration or other termination of their terms of office.

Indebtedness - The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time shall be incorporated into and made a part of the agreement.

Ethics - The Board of Education Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budget(s).
