## AMEND BOARD REPORT 08-1119-ED4 AMEND BOARD REPORT 08-0625-ED14

AUTHORIZE TUITION PAYMENTS TO OTHER PUBLIC SCHOOL DISTRICTS, COOPERATIVES AND PRIVATE PROVIDERS ON BEHALF OF PUBLIC SCHOOL DISTRICTS FOR EDUCATIONAL SERVICES PROVIDED TO DISTRICT 299 RESIDENTS PLACED BY VARIOUS STATE AGENCIES

### THE CHIEF EXECUTIVE OFFICER REPORTS THE FOLLOWING DECISION:

Authorize tuition payments to other public school districts, cooperatives outside of Chicago, and private providers on behalf of public school districts for educational services provided to students with severe disabilities and/or severe substance abuse problems who reside in District 299, but they have been placed in schools outside of District 299. Tuition payments between July 1, 2008 and June 30, 2009 shall not exceed \$2,700,000.00 \$4,415,439.00 in the aggregate. No written agreements are required for these tuition payments. Information pertinent to this program is stated below.

This amended Board Report is necessary to do the following: (i) add one public school district (#46) to the list of school districts affiliated with this program; (ii) correct the name of one school district (#38); (iii) remove one school district (# 28) from the list of school districts affiliated with this program; and (iv) update one of the budget classifications.

This amended Board Report is necessary to increase the not to exceed amount from \$2,700,000.00 to \$4,415,439.00 in the aggregate to provide for additional students enrolled in these school districts and update the User department contact information.

**PAYMENT PERIOD:** Tuition payments are authorized for school districts outside of Chicago from July 1, 2008 through June 30, 2009.

**PROGRAM DESCRIPTION:** Payments of tuition on a per capita basis are made for students who are residents of the Chicago Public School district and attend school districts outside of Chicago. Currently, 28 students have been placed residentially through a state agency and reside too far from Chicago to be transported to Chicago Public Schools. An additional 30 students require unique and complex special education services that are unavailable within CPS. The number of students requiring these out of district placements may vary during the year based upon the needs of each student.

**PARTICIPANTS:** Participants are other public school districts, cooperatives outside of Chicago, and private providers on behalf of public school districts. The school districts outside of Chicago send monthly attendance reports, quarterly student progress reports and Individualized Education Program (IEP) documents for each student to the CPS Case Manager.

**OUTCOMES:** By paying tuition to school districts outside of Chicago, the Board is able to meet the needs of students in the least restrictive environment.

**COMPENSATION:** Tuition payments to school districts outside of Chicago during the payment period shall not exceed \$2,700,000.00 \$4,415,439.00 in the aggregate.

**REIMBURSABLE EXPENSES:** Reimbursement for transportation costs to schools that provide transportation services to students as part of their program will be reviewed and authorized by the Chief Specialized Services Officer, not to exceed \$200,000.00 in the aggregate, which amount is included in the total compensation

**AUTHORIZATION:** The Chief Specialized Services Officer is authorized to direct payments to those various school districts outside of Chicago, as necessary and sign any required ancillary documents.

**AFFIRMATIVE ACTION:** Pursuant to Section 5.2.3 of the Remedial Program for Minority and Women Owned Business Enterprise Participation in Goods and Services contracts (M/WBE Plan), tuition payments to other educational institutions are exempt from M/WBE review.

LSC REVIEW: Local School Council approval is not applicable to this report.

#### **GENERAL CONDITIONS:**

Inspector General – Each party to the agreement shall acknowledge that, in accordance with 105 ILCS 5/34-13.1, the Inspector General of the Board of Education has the authority to conduct certain investigations and that the Inspector General shall have access to all information and personnel necessary to conduct those investigations.

Conflicts – The agreement shall not be legally binding on the Board if entered into in violation of the provisions of 105 ILCS 5/34-21.3 which restricts the employment of, or the letting of contracts to, former Board members during the one year period following expiration or other termination of their terms of office.

Indebtedness – The Board's Indebtedness Policy adopted June 26, 1996 (96-0626-PO3), as amended from time to time, shall be incorporated into and made a part of the agreement.

Ethics – The Board's Ethics Code adopted June 23, 2004 (04-0623-PO4), as amended from time to time, shall be incorporated into and made a part of the agreement.

Contingent Liability – The agreement shall contain the clause that any expenditure beyond the current fiscal year is deemed a contingent liability, subject to appropriation in the subsequent fiscal year budgets.
