SCOPE OF DUTIES: The teacher will work with a team of researchers who will be exploring role of video in teacher learning. The teachers will observe teachers using wearable cameras to attend student math thinking. The information will be used to support and pre-service math teachers. The teachers' duties while on loan will be consistent with the Board's Policy on On-Loan Leaves to Educational Institutions (07-0725-PO2).
