

PHASE-OUT RICHARD T. CRANE TECHNICAL PREPARATORY HIGH SCHOOL, CO-LOCATE CHICAGO TALENT DEVELOPMENT HIGH SCHOOL AND RICHARD T. CRANE TECHNICAL PREPARATORY HIGH SCHOOL IN THE 2245 WEST JACKSON BOULEVARD FACILITY, AND ADJUST THE ATTENDANCE BOUNDARIES OF WELLS COMMUNITY ACADEMY HIGH SCHOOL, JOHN MARSHALL METROPOLITAN HIGH SCHOOL, MANLEY CAREER ACADEMY HIGH SCHOOL, AND DAVID G. FARRAGUT CAREER ACADEMY HIGH SCHOOL

THE CHIEF EXECUTIVE OFFICER RECOMMENDS:

That effective June 30, 2012, the Chicago Board of Education phase-out Richard T. Crane Technical Preparatory High School (School ID 609702) ("Crane HS"), located at 2245 West Jackson Boulevard, Chicago, Illinois, for academic reasons, co-locate Crane HS and Chicago Talent Development High School (School ID 400093) ("Talent Development HS"), located at 4319 West Washington Boulevard, Chicago, Illinois, in the facility located at 2245 West Jackson Boulevard, Chicago, Illinois, and that the attendance areas of Wells Community Academy High School (School ID 609740) ("Wells HS"), located at 936 North Ashland Avenue, Chicago, Illinois, John Marshall Metropolitan High School (School ID 609723) ("Marshall HS"), located at 3250 West Adams Street, Chicago, Illinois, Manley Career Academy High School (School ID 609722) ("Manley HS"), located at 2935 West Polk Street, Chicago, Illinois, and David G. Farragut Career Academy High School (School ID 609704) ("Farragut HS"), located at 2345 South Christiana Avenue, Chicago, Illinois, be adjusted to include portions of Crane's attendance area.

DESCRIPTION:

Pursuant to Public Act 097-0474 ("Public Act"), the Chief Executive Officer's Guidelines for School Actions, and the Board of Education's Policy on the Review and Establishment of School Attendance Boundaries, 05-0622-PO1, the Chief Executive Officer ("CEO") of the Chicago Public Schools may recommend to the Board the phase-out of schools, co-location of schools, and the adjustment of school attendance boundaries.

Pursuant to the Public Act's requirements, two community meetings were convened on January 6, 2012 and January 20, 2012 at Malcom X College, located at 1900 West Van Buren Street, Chicago, Illinois, and a public hearing was convened on January 24, 2012 at 125 South Clark Street, 5th floor, Chicago, Illinois, following the issuance of proper notice. An independent hearing officer received oral and written comments and supporting documents at the hearing and kept the record open after the hearing to receive additional written comments or documentation. A transcript of the hearing and summaries of the meetings have been provided to the Board. The hearing officer reported that the CEO's proposal met the requirements of the Public Act and summarized comments and written documentation received, including the Crane Coalition Academic Improvement Plan. The hearing officer recommended that the Board order an analysis of the proposed plan before determining whether to approve the CEO's proposed action. Upon receipt of the hearing officer's report, the Board directed the CEO or his designees to analyze and report on the merits of the Crane Coalition Academic Improvement Plan. After receiving the hearing officer's report, reviewing the Crane Coalition Academic Improvement Plan and providing to the Board a report explaining why the Crane Coalition Academic Improvement Plan is not feasible, the CEO has decided to recommend that the Board phase-out Crane HS effective June 30, 2012, co-locate Crane HS and Talent Development HS in the facility located at 2245 West Jackson Boulevard, and assign portions of the Crane HS attendance area to Wells HS, Marshall HS, Manley HS, and Farragut HS.

Furthermore, although the CEO does not recommend the proposed Crane Coalition Academic Improvement Plan, the CEO and his designees believe the authors of the Crane Coalition Academic Improvement Plan are committed to the development of a rigorous high school option for students living in the vicinity of the Crane facility. Therefore, the CEO and his designees have committed themselves to work with the Crane Coalition to develop a new high school in the Crane building that would start with a 9th Grade in Fall 2013. Specifically, the CEO is committed to formulating the Crane Transformational Task Force that will plan a new health sciences high school at the 2245 West Jackson Boulevard facility

for fall of 2013. The CEO shall present the Task Force's plan for this new high school to the Board no later than September 26, 2012.


